SENATE BILL 402

1 AN ACT TO AMEND CHAPTER 57 OF THE GENERAL STATUTES AND VARIOUS  
2 SECTIONS OF CHAPTER 58 OF THE GENERAL STATUTES RELATED THERETO  
3 IN ORDER TO MAKE THE SAME APPLICABLE TO DENTAL SERVICE  
4 CORPORATIONS.

6 The General Assembly of North Carolina do enact:  
7

8 **Section 1.** Chapters 57 and 58 of the General Statutes, as the same appear in the  
9 1960 Replacement Volume 2B, are hereby amended as follows:

10 (a) Chapter 57 shall be entitled "Hospital, Medical and Dental Service  
11 Corporations".

12 (b) The words "and/or dental" are inserted following the word "medical" in the  
13 following places:

38 (e) The title to G.S. 57-3 shall be entitled "Hospital, physician and dentist  
39 contracts".

40 (f) The following paragraph is added to G.S. 57-1 and shall be placed between  
41 the present third and fourth paragraphs thereof:

1 "The term 'dental service plan' as used in this Chapter includes contracting for the payment  
2 of fees toward, or furnishing of dental and/or any other professional services authorized or  
3 permitted to be furnished by a duly licensed dentist."

4 **Sec. 2.** All laws and clauses of laws in conflict with this Act are hereby repealed.

5 **Sec. 3.** This Act shall be in full force and effect from and after its ratification.

6 In the General Assembly read three times and ratified, this the 22nd day of June,  
7 1961.
