SENATE BILL 512

1 AN ACT TO APPROPRIATE TO THE RESPECTIVE CORRECTIONAL SCHOOLS
2 ADDITIONAL AMOUNTS REQUIRED TO PROVIDE SALARY INCREASES FOR
3 THEIR INSTRUCTIONAL PERSONNEL EQUIVALENT TO SALARY INCREASES
4 PROVIDED BY CHAPTER 833 OF 1961 SESSION LAWS FOR SIMILAR
5 PERSONNEL IN THE PUBLIC SCHOOLS FOR 1961-63 BIENNIUM.

7 WHEREAS, teachers and other instructional personnel in the Correctional Schools
8 of the State have for many years been certified and paid on the same basis as similar personnel
9 employed in the public schools; and

10 WHEREAS, it is found that the Budget Current Operations Appropriation Act for
11 the Biennium 1961-63 does not include sufficient funds to provide salary increases for teachers
12 and other instructional personnel in the Correctional Schools which will be equivalent to salary
13 increases provided by Chapter 833 of the 1961 Session Laws for similar instructional personnel
14 employed in the public schools; and it is highly desirable to remedy said deficiency: Now,
15 therefore,

17 The General Assembly of North Carolina do enact:

19 **Section 1.** There is hereby appropriated out of the General Fund of the State to the
20 respective correctional institutions hereinafter named, and for each fiscal year as indicated, the
21 following sums to be used exclusively for the purpose of providing salary increases to teachers
22 and other instructional personnel, not to exceed in any individual case the monthly salary which
23 such individual would be entitled to receive from the State if said individual were employed in
24 the same work in a public school:

36 **Sec. 2.** The appropriations herein made shall be in addition to all other
37 appropriations made for the said institutions in Chapter 833 of the 1961 Session Laws to
38 support current operations of the respective institutions.

39 **Sec. 3.** All laws and clauses of laws in conflict with this Act are hereby repealed.

40 **Sec. 4.** This Act shall become effective on July 1, 1961.
