HOUSE BILL 308

1 AN ACT TO MAKE WILMINGTON COLLEGE AND ASHEVILLE-BILTMORE  
2 COLLEGE CAMPUSES OF THE UNIVERSITY OF NORTH CAROLINA UNDER THE  
3 DESIGNATIONS OF "THE UNIVERSITY OF NORTH CAROLINA AT  
4 WILMINGTON". AND "THE UNIVERSITY OF NORTH CAROLINA AT  
5 ASHEVILLE."

7 The General Assembly of North Carolina do enact:

8  
9 **Section 1.** G.S. 116-2 is amended by adding at the end of subsection (b) of said  
10 section the following:

11 "On July 1, 1969, the University of North Carolina at Wilmington shall become a campus  
12 of the University of North Carolina.

13 "On July 1, 1969, the University of North Carolina at Asheville shall become a campus of  
14 the University of North Carolina."

15 **Sec. 2.** A new Part 3B of Article 1 of Chapter 116 of the General Statutes is enacted  
16 to read as follows:

17 "Part 3B. The University of North Carolina at Wilmington."

18 **"Sec. 116-39.1. The University of North Carolina at Wilmington.** (a) Wilmington College  
19 shall become a campus of the University of North Carolina under the designation the  
20 University of North Carolina at Wilmington on July 1, 1969, whereupon it shall cease to be  
21 subject to any of the provisions and terms of Article 2, Chapter 116 of the General Statutes, and  
22 shall become subject to the terms of Article 1, Chapter 116 of the General Statutes.

23 "(b) The Board of Trustees of Wilmington College shall, on or before July 1, 1969,  
24 execute proper legal instruments conveying to The University of North Carolina, without  
25 consideration, all right, title and interest of the grantor in and to the real and personal property  
26 of Wilmington College, including all endowments, executors contracts, and unexpended State  
27 appropriations or other appropriations; New Hanover County and the City of Wilmington shall  
28 continue to be solely liable for the repayment of all indebtedness incurred by that county in aid  
29 of Wilmington College."

30 **Sec. 3.** A new Part 3C of Article 1 of Chapter 116 of the General Statutes is enacted  
31 to read as follows:

32 "Part 3C. The University of North Carolina at Asheville."

33 **Sec. 116-39.2. The University of North Carolina at Asheville.** (a) Asheville-Biltmore  
34 College shall become a campus of the University of North Carolina under the designation the  
35 University of North Carolina at Asheville on July 1, 1969, whereupon it shall cease to be  
36 subject to the terms and provisions of Article 2, Chapter 116 of the General Statutes, and shall  
37 become subject to the terms of Article 1, Chapter 116 of the General Statutes.

38 "(b) The Board of Trustees of Asheville-Biltmore College shall, on or before July 1,  
39 1969, execute proper legal instruments conveying to The University of North Carolina, without  
40 consideration, all right, title and interest of the grantor in and to the real and personal property  
41 of Asheville-Biltmore College, including all endowments, executors contracts, and unexpended  
42 State appropriations or other appropriations; Buncombe County, the City of Asheville  
43 participating in the financial affairs of said college, shall continue to be solely liable for the

1 repayment of all indebtedness incurred by said county and municipalities in aid of Asheville-  
2 Biltmore College, if such obligations have been heretofore contracted for and assumed."

3       **Sec. 4.** Amend the title to Article 2 of Chapter 116 of the General Statutes by  
4 striking out the comma, appearing after the words "Winston-Salem State College", and by  
5 inserting in lieu of said comma a period, and by striking out from said title, or caption, the  
6 following: "Asheville-Biltmore College, Wilmington College."

7       **Sec. 5.** Subsection (6) of G.S. 116-45 be, and the same is hereby, repealed.

8       **Sec. 6.** G.S. 116-45.2 be, and the same is hereby, repealed.

9       **Sec. 7.** Subsection ill of G.S. 116-175 is hereby amended by striking out the  
10 comma, appearing after the words "Winston-Salem College", in the last two lines of said  
11 subsection, and by inserting in lieu thereof a period, and by striking out in the last line of said  
12 subsection the words: "Asheville-Biltmore College" and "Wilmington College."

13       **Sec. 8.** G.S. 116-189 Subsection ill is amended by striking out, in the fourth line of  
14 said subsection (1), the words "Asheville-Biltmore College", and by striking out, in the sixth  
15 and seventh lines of said subsection 111, the words "Wilmington College."

16       **Sec. 9.** All laws and clauses of laws in conflict with this Act are hereby repealed.

17       **Sec. 10.** G.S. 116-39.1(b) and G.S. 116-39.2(b) set forth in Section 2 and Section 3  
18 of this Act, shall take effect upon the ratification of this Act. The remainder of this Act shall  
19 take effect on July 1, 1969.

20       In the General Assembly read three times and ratified, this the 24th day of April,  
21 1969.
