1 AN ACT TO ESTABLISH ELIZABETH CITY STATE COLLEGE, FAYETTEVILLE
2 STATE COLLEGE AND WINSTON-SALEM STATE COLLEGE REGIONAL

5 The General Assembly of North Carolina do enact:

7 **Section 1.** The caption or title of Article 2 of Chapter 116 of the General Statutes is
8 hereby amended by striking therefrom the words "Elizabeth City State College, Fayetteville
9 State College, Winston-Salem State College,".

10 **Sec. 2.** Article 1A of Chapter 116 of the General Statutes, entitled "Regional
11 Universities", is hereby amended to add a new Section to read as follows:

12 "Effective July 1, 1969:

13 "(1) Elizabeth City State College is redesignated 'Elizabeth City State
14 University', and is made subject to the provisions of Section 116-44.10.

15 "(2) In all other statutes and titles or captions thereof, the words 'Elizabeth City
16 State College' are amended to read 'Elizabeth City State University'."

17 **Sec. 3.** Article 1A of Chapter 116 of the General Statutes, entitled "Regional
18 Universities", is hereby amended to add a new Section to read as follows:

19 "Effective July 1, 1969:

20 "(1) Fayetteville State College is redesignated 'Fayetteville State University', and
21 is made subject to the provisions of Section 116-44.10.

22 "(2) In all other statutes and titles or captions thereof, the words 'Fayetteville
23 State College' are amended to read 'Fayetteville State University'."

24 **Sec. 4.** Article 1A of Chapter 116 of the General Statutes, entitled "Regional
25 Universities", is hereby amended to add a new Section to read as follows:

26 "Effective July 1, 1969:

27 "(1) Winston-Salem State College is redesignated 'Winston-Salem State
28 University', and is made subject to the provisions of Section 116-44.10.

29 "(2) In all other statutes and titles or captions thereof, the words 'Winston-Salem
30 State College' are amended to read Winston-Salem State University'."

31 **Sec. 5.** Subsection (5) of Section 116-45 of the General Statutes is hereby repealed.

32 **Sec. 6.** Chapter 130 of the Session Laws of 1969 is repealed effective July 1, 1969.

33 **Sec. 7.** Section 116-45.1 of the General Statutes is hereby repealed.

34 **Sec. 8.** All laws and clauses of laws in conflict with this Act are hereby repealed.

35 **Sec. 9.** This Act shall be in full force and effective from and after July 1, 1969.
