SENATE BILL 701

1 AN ACT TO AUTHORIZE THE NORTH CAROLINA STATE BOARD OF DENTAL  
2 EXAMINERS TO ISSUE PROVISIONAL LICENSES TO CERTAIN QUALIFIED  
3 DENTISTS.

5 The General Assembly of North Carolina do enact:  
6

7 **Section 1.** Chapter 90 of the General Statutes is hereby amended by adding a new  
8 section immediately following G.S. 90-29.2 to read as follows:

9 **"G.S. 90-29.3. Provisional License.** (a) The North Carolina State Board of Dental Examiners  
10 shall, subject to its rules and regulations, issue a provisional license to practice dentistry to any  
11 person who is licensed to practice dentistry anywhere in the United States or in any country,  
12 territory or other recognized jurisdiction, if the Board shall determine that said licensing  
13 jurisdiction imposed upon said person requirements for licensure no less exacting than those  
14 imposed by this State. A provisional licensee may engage in the practice of dentistry only in  
15 strict accordance with the terms, conditions and limitations of his license and with the rules and  
16 regulations of the Board pertaining to provisional license.

17 (b) A provisional license shall be valid until the date of the announcement of the results  
18 of the next succeeding Board examination of candidates for licensure to practice dentistry in  
19 this State, unless the same shall be earlier revoked or suspended by the Board.

20 (c) No person who has failed an examination conducted by the North Carolina State  
21 Board of Dental Examiners shall be eligible to receive a provisional license.

22 (d) Any person desiring to secure a provisional license shall make application therefor  
23 in the manner and form prescribed by the rules and regulations of the Board and shall pay the  
24 fee prescribed in Section 90-39 of this Article.

25 (e) A provisional licensee shall be subject to those various disciplinary measures and  
26 penalties set forth in Section 90-41 upon a determination of the Board that said provisional  
27 licensee has violated any of the terms or provisions of this Article."

28 **Sec. 2.** G.S. 90-40 is hereby amended by inserting after the word "Examiners" in  
29 the fourth line of said Section the words "or having obtained a provisional license from said  
30 Board".

31 **Sec. 3.** G.S. 90-41.1 is hereby amended by placing a comma after the word  
32 "licensee" in the first line of the text thereof and inserting after the comma "provisional  
33 licensee".

34 **Sec. 4.** All laws and clauses of laws in conflict with the provisions of this Act are  
35 hereby repealed.

36 **Sec. 5.** This Act shall be in full force and effect from and after its ratification.  
37 In the General Assembly read three times and ratified, this the 11th day of June,  
38 1969.
