HOUSE BILL 1212

1 AN ACT TO MAKE THE MOTOR VEHICLE LAWS OF THE STATE APPLICABLE TO
2 THE STREETS, ROADS, ALLEYS, AND DRIVEWAYS ON THE CAMPUS OF
3 WESTERN CAROLINA UNIVERSITY.

5 The General Assembly of North Carolina do enact:

7 **Section 1.** All of the provisions of Chapter 20 of the General Statutes relating to the
8 use of the highways of the State and the operation of motor vehicles thereon are hereby made
9 applicable to the streets, roads, alleys and driveways on the campus of Western Carolina
10 University. Any person violating any of the provisions of said Chapter 20 of the General
11 Statutes, as herein made applicable, in or on the streets, roads, alleys or driveways on the
12 campus of Western Carolina University shall, upon conviction thereof, be punished as therein
13 prescribed and as provided by Chapter 20 of the General Statutes, relating to motor vehicles.
14 Nothing herein contained shall be construed as in any way interfering with the ownership and
15 control of such streets, roads, alleys and driveways on the campus of Western Carolina
16 University as is now vested by law in the Board of Trustees of Western Carolina University.

17 **Sec. 2.** The Board of Trustees of Western Carolina University is authorized and
18 empowered to make such additional rules and regulations and adopt such additional ordinances
19 with respect to the use of the streets, roads, alleys and driveways on the campus of Western
20 Carolina University, and to establish parking areas on the said campus not inconsistent with the
21 provisions of Chapter 20 of the General Statutes of North Carolina. All regulations and
22 ordinances adopted pursuant to the authority of this Section shall be recorded in the
23 proceedings of the Board of Trustees, printed, and copies of such regulations and ordinances
24 shall be filed in the Office of the Secretary of State of North Carolina. Any person violating any
25 of such regulations or ordinances shall, upon conviction thereof, be guilty of a misdemeanor,
26 and shall be punishable by a fine of not exceeding fifty dollars (\$50.00) or imprisonment for
27 not exceeding thirty (30) days or, in the discretion of the Court, both such fine and
28 imprisonment.

29 **Sec. 3.** The Board of Trustees of Western Carolina University may by regulation or
30 ordinance provide for a system of registration of all motor vehicles where the owner of said
31 motor vehicle intends and does park same in the parking places or assigned parking places on
32 the campus of Western Carolina University or the owner keeps said vehicle on the campus of
33 Western Carolina University. The Board of Trustees of Western Carolina University may by
34 regulation or ordinance establish a system of citations that may be issued to owners of motor
35 vehicles who park their vehicles on the campus of said University in violation of the traffic or
36 parking regulations as established by law or regulation. The Board of Trustees of Western
37 Carolina University may by regulation or ordinance provide that the administrative officers or
38 the Student Government or a combination thereof may administer said system of citations and
39 exercise the right to prohibit repeated violators of such ordinances and regulations from parking
40 on the campus or using the parking facilities thereof.

41 **Sec. 4.** All laws and clauses of laws in conflict with the provisions of this Act are
42 hereby repealed.

43 **Sec. 5.** This Act shall be in full force and effect from and after its ratification.
