The Agricultural Development and Farmland Preservation Trust Fund 2010-11 Fiscal Year Report

The primary objective of the ADFP Trust Fund is to fund projects that encourage the preservation of qualifying agricultural, horticultural, and forestlands while fostering the growth, development, and sustainability of family farms. The Trust Fund was established by the General Assembly in 2005 with an initial \$50,000 appropriation. A 19 member Advisory Committee which is chaired by the Commissioner of Agriculture advises the NC Department of Agriculture & Consumer Services on the administration of grant funds provided to county governments and non-profit conservation organizations. Grants are provided for the removal of development rights through perpetual and term easements. Grants are also provided for agricultural development projects and plans.

Historical Funding

The General Assembly appropriated \$8 million for the 2007-08 fiscal year, \$4 million for 2008-09 fiscal year, \$2 million for the 2009-10 fiscal year and \$2 million for the 2010-11 fiscal year. For the 2010-11 fiscal year, the ADFP Trust Fund returned \$2,173,989 at the request of the Office of State Budget and Management.

The ADFP Trust Fund has awarded approximately \$13.7 million for 95 grant contacts in the first three grant cycles. As of June 30, 2011, seventy seven of the contracts have been completed and closed out. The ADFP Trust Fund has paid out \$8.9 million and has an additional \$3.7 million still under contract for grant cycles I, II, & III. Matching funds for closed grant projects is more than \$39.3 million and the estimated matching funds associated with the current open contracts is more than \$8.2 million. The current ratio of matching expenditures to grant expenditures for the closed projects is 4.4 to 1.

Achievements to Date

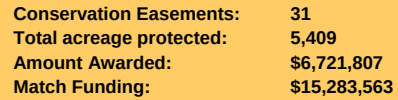
Approximately 76% of all grant funding has been awarded to easement projects for a total of 46 easement contracted projects of which 31 projects have been closed. These closings accounted for 4,232 acres having received perpetual easements and 1,177 acres having received term easements which removed development rights while allowing the continuation of farming and forestry practices on the land. Attached is a listing of recorded ADFP Trust Fund easements during the 2010-11 fiscal year. The other 15 open easement contracts have 2,206 acres of land awaiting the recording of a perpetual easement.

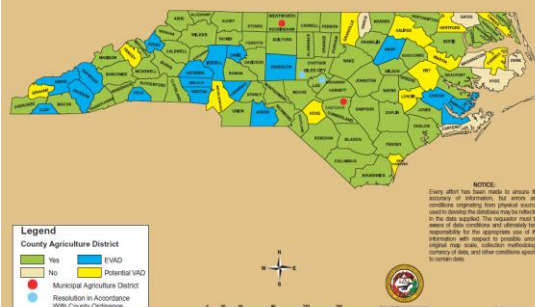

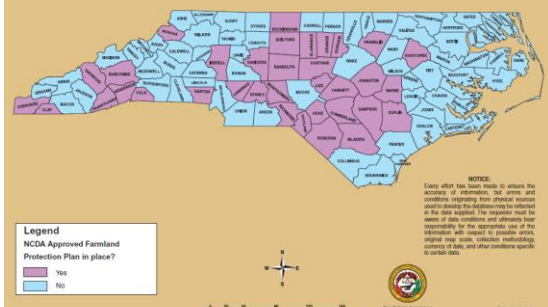

A few of the more prominent development projects that have received ADFP Trust Fund assistance in the first grant cycles include WNC Regional Livestock Facility in Waynesville and the Piedmont Food Processing Center in Hillsborough. These types of facilities have provided improved marketing opportunities and profits for farmers in those regions by adding additional values to the products being sold or establishing a market that allows the farm products a more visible and creditable marketing outlet. These types of activities are essential in maintaining profitability for a producer to stay on the land and be a key contributor to the local community economically. These projects not only enhance the competitiveness of North Carolina agriculture products but also help our citizens with a local supply of healthy produced products. By producing locally our dependence on foreign resources including foreign oil is reduced due the reduction of transportation costs which also helps to decrease our carbon footprint.

Future Plans & Projects

Cycle IV have been reviewed and recommendations made by the ADFP Advisory Committee and accepted by Commissioner Steve Troxler. Selected applicants have been notified and will be awarded contracts using the \$1.7 million state appropriation for 2011-12 and anticipated grant returns from current open grants from grant cycles I, II, and III. ADFP Trust Fund Cycle IV has 46 applicants requesting \$12.6 million with estimated matching resources of \$26.5 million. From these 46 applications, 19 grantees were selected for grant awards totaling \$1,805,323 for an overall estimated project value of \$5.1 million. Ten of the grants to be awarded totaling \$503,000 were for projects and plans. The remaining nine awarded grants were for 8 perpetual easements and 1 term easement totaling \$1,302,323 to be placed on 740 acres of crop and forest land. For the fiscal year 2011-12, the ADFP Trust Fund has plans to solicit requests for proposals (RFPs) for a cycle V granting program. These proposals will be used to select and award grants from anticipated state appropriations for fiscal year 2012-13.
