Explanatory Memorandum

The attached document summarizes grant activity for fiscal year 2010-2011 for both the Industrial Development Fund and the affiliated Utility Account. In addition to awards made during the period in question, the document also reflects projects in which funds have been encumbered in anticipation of an acceptable application. A final grouping captures pre-applications that have been submitted that do not yet include the encumbrance of funds due to the scarcity of financial resources. It is our expectation that as funds become available, these projects will move up the chain to include an associated encumbrance and eventually, a successful application.

As a brief reminder of how the Industrial Development Fund operates, grants are made to a unit of local government to assist in economic development and job creation. As has often been the case over the last 24 months, awards are made in partnership with a specific project or company recruitment and play an important role in the success of these recruitments. Because the North Carolina Department of Commerce has become increasingly aggressive in our job creation efforts, it would not be unusual to have a number of different performance-based programs at work during any given recruitment. As a result, I would be reluctant to attribute the success of any recruitment solely to the IDF but I strongly believe it plays a critical role. In many cases, the publicly-owned infrastructures that these grants help provide are often mentioned as a tipping point in the decision-making process. So while I do not believe all the credit for the jobs listed can go to the IDF, I would caution against downplaying the significance of their participation.

A final explanatory note: When IDF awards are made, the entire amount is encumbered but the project may take 24-36 months to complete, depending on the complexity of the project and the needs of a particular company. So in this regard, a \$500,000 grant made in April may not have seen any funds actually spent as of yet, whereas an award made in 2009 may still be drawing down on their funds. We monitor the ebb and flow of these funds very closely to insure we are responsible guardians of the State's resources, and the attached spreadsheet is the most accurate reflection of our efforts.
