North Carolina General Statute 131E-314 requires NC Medicaid [Division of Health Benefits] (the Division or DHB) to report quarterly to the Joint Legislative Oversight Committee on Health and Human Services on NC Medicaid's regulatory activities in the enforcement of Article 17 of Chapter 131E, which provides for the licensure of Provider Sponsored Organizations (PSOs).
