Upon completing a comparison of the cash balance and solvency range of each LME/MCO on December 1, 2018, as required by G.S.122C-125.2(b), the Secretary of Health and Human Services may adjust the specified recurring and nonrecurring reductions among the LME/MCOs; provided, however, that the Secretary shall submit a detailed explanation for any such adjustment along with supporting documentation to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal Research Division within 10 business days after making the adjustment.
