Dear Chairmen:

Please find enclosed the Department of Health and Human Services ("Department") report pursuant to Section 12F.2.(c) of Session Law 2015-241. The information provided identifies Single Stream Fund expenditures by LME-MCO with a State average and benchmark for spending expectations for April 2017. The benchmark for the expected single stream funding expenditure for this portion of the fiscal year is 83% of the total annual allocation. The statewide average is 83.9% which is above the overall expectation for spending for services.

The graph for the report has been modified to demonstrate the individual LME-MCOs performance by month compared to static targeted expenditures expectations. The visual supports the historic explanation of spending trends across the fiscal year.

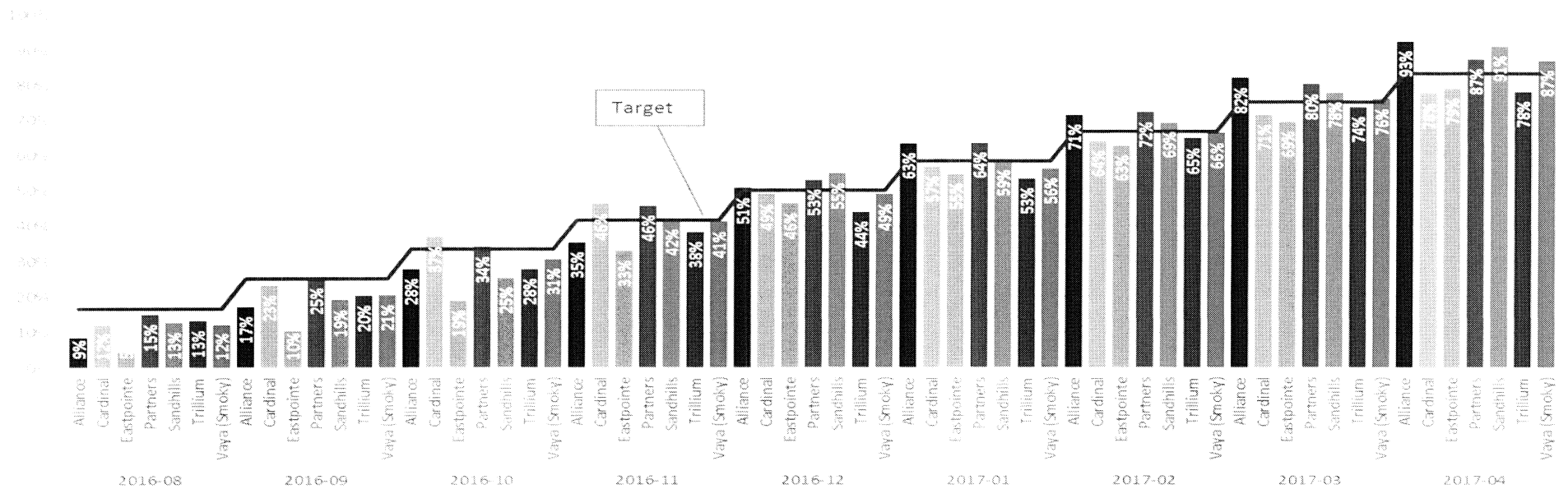
