

INTERIM REPORT ON BLUE RIBBON COMMISSION ON TRANSITION TO COMMUNITY LIVING REPORT: RECOMMENDATION THREE

SUMMARY

This is the interim status report from the Department of Health and Human Services (DHHS) on Recommendation Three from the "Blue Ribbon Commission on Transition to Community Living Final Report":

"The Department shall establish a workgroup including stakeholders, departmental personnel, and unbiased experts, to explore changes to NC's long-term care continuum, including but not limited to: expansion of waiver options and potential new licensure structure, and assuring that individuals are not unduly offered more restrictive placements than needed and are assured of receiving skilled nursing care as designated through assessment"

STATUS UPDATE

On February 27, 2013, a diverse workgroup convened with representatives from the various long-term supports communities, including self-advocates, family members, provider representatives, state staff, advocacy organizations, Blue Ribbon Commission members, the Senior Tarheel Legislature, the NC Institute of Medicine, and academicians. The workgroup will integrate similar departmental initiatives, including the NC DHHS *Olmstead* Planning Committee, to minimize the duplication of efforts and to leverage the strengths and resources of all efforts.

The vision is to create a seamless array of supports to ensure community services are as readily available as facility-based options. The final response will also promote person-centered planning, individual choice, individual responsibility and access to safe, affordable housing.

Major objectives of the workgroup include:

- 1. Define and confirm the current continuum
- 2. Evaluate barriers for individuals receiving publicly funded long- term care services
- 3. Explore other states' strategies and synthesize these strategies along with North Carolina's previous initiatives and recommendations
- 4. Develop recommendations to create a comprehensive plan for Long Term Services in North Carolina

On or before October 1, 2013, DHHS will submit a final report to the General Assembly's Senate Appropriations Committee on Health and Human Services, the House Appropriation Subcommittee on Health and Human Services, and the Joint Legislative Oversight Committee on Health and Human Services.
