RE: G.S. §114-2.5; Report on Settlement Agreement for Advanced Bionics Corporation

## Dear Members:

Section 114-2.5 of the North Carolina General Statutes requires the Attorney General to report to the Joint Legislative Commission on Governmental Operations and the Chairs of the Appropriations Subcommittees on Justice and Public Safety regarding all settlements and court orders which result in more than \$75,000.00 being paid to the State. Pursuant to that statute, I am writing regarding the settlement of claims for Medicaid reimbursement to the state and federal governments in the above-referenced matter. Pursuant to federal law (42 C.F.R. § 433.320) recoveries in these cases are shared on a pro rata basis by the state and federal governments.

A settlement has been executed between Advanced Bionics Corporation and the State of North Carolina.

The settlement resolves allegations that from January 1, 2011 through December 31, 2019, Advanced Bionics Corporation submitted false claims to the Medicaid program

by submitting fraudulent tests results to the FDA to obtain regulatory approval for its cochlear implants.

Under the terms of North Carolina's settlement, the State of North Carolina will recover \$138,789.56. Of that amount the federal government will receive \$78,111.76 for North Carolina's federal portion of Medicaid recoveries. Pursuant to G.S. § 1-610, the qui tam plaintiffs whose whistleblower actions brought this matter to the government's attention will receive \$9,905.81 of North Carolina's recovery. The North Carolina Medicaid Program will receive \$24,145.75 as restitution and interest. In addition, pursuant to Article IX, Section 7 of the North Carolina Constitution and G.S. § 115C-457.1, the penalty portion of the settlement in the amount of \$24,222.54 will be paid to the Civil Penalty Forfeiture Fund for the support of North Carolina public schools. Pursuant to G.S. § 115C-457.2 and G.S. § 1-608(c), the North Carolina Department of Justice will receive \$2,403.70 for investigative costs and costs of collection.
