The recent Medicaid transformation to Medicaid Managed Care Health Plans will shift many of the duties of DHB to the Prepaid Health Providers (PHPs). This shift of duties will result in a shift of the cases from appeals filed against DHB to appeals filed against the PHPs. The North Carolina Department of Justice (DOJ) does not represent the PHPs in these appeals; however, the Medicaid recipient appeal attorneys have several other types of cases that require representation on behalf of DHB. DHB has asked that position 65026423 be held vacant during this transition period. The transition period continues to be extended with a new start date for PHPs on April 1, 2023. DHB and DOJ will determine if the vacancy needs to be filled after the amount of incoming work is steady, and an accurate caseload can be determined.
