A. Introduction

In the recent 2021-2022 biennial budget bill¹ the General Assembly appropriated \$100,000,000 to provide local administrative units funds for salary supplements to teachers and qualifying school administrators. The legislation directed the State Board of Education (SBE) to report on the following information:

- (1) *A list of all eligible counties and eligible local school administrative units.*
- (2) *Funds allocated to each eligible local school administrative unit.*
- (3) *The percentage and amount of teachers and qualifying school administrators in each eligible local school administrative unit receiving salary supplements.*
- (4) *The average salary supplement amount in each eligible local school administrative unit.*
- (5) *The range of salary supplement amounts in each eligible local school administrative unit.*
- (6) *The effect of the salary supplements on the retention of teachers and qualifying school administrators in eligible local school administrative units.*
- (7) *The identity of any local school administrative unit that the State Board determines has supplanted funds.*

B. Availability of Requested Data

Due to the late passage of the 2021-22 budget, there was insufficient data to provide all the requested information by the April 15, 2022 deadline. The following is the timeline that transpired.

November 18, 2021, the Appropriations Bill was signed into law

January 20, 2022, the budget was certified by Office of State Budget and Management

February 16, 2022, the allocations were provided to the local administrative units with accompanying guidance

February 16 to May, the local administrative units determined the supplement distribution to the eligible personnel and received local board approval.

As a result, this report contains only the requirements of (1) and (2), for which information is available.
