### **Description of Funding**

The purpose of the State Transportation Reserve Fund for Homeless (McKinney-Vento) and Foster Children is to provide for a grant program to cover the extraordinary school transportation costs for homeless and foster children in Public School Units, [S.L. 2021-180, sec. 7.12\(c\)](#). The guidelines for funds are:

- North Carolina Legislature allots additional transportation funds for students experiencing homelessness and students in Foster Care
- Funding must be applied for or waived by a Public School Unit (PSU), including charter schools
- Allocations will be available from July 1 thru June 30 each school year
- NC Department of Public Instruction (NCDPI) will receive the annual allocation through the NC state budget
- Funds are reoccurring funds within the state budget

Additional information about the funding source can be viewed in the Current Operations Appropriations Act, 2021 Session Laws 2021-180 (S.B.-105) Section 7.12(b), page 64.

### **Eligibility & Funding Amount**

- Public School Units (PSUs), including charter schools
- Awards cannot exceed fifty percent (50%) of the extraordinary transportation costs
- Priority shall be given to applicants in proportion to the extent that their applications and prior-year expenditures demonstrate the use of available federal funds to cover the cost of transporting homeless and foster children

### **Requirements of Receiving State Funding**

1. Complete the on-line application
2. Public School Units (PSU) Transportation Director, Homeless Liaison, and Foster Care Point of Contact (POC) must collaborate to determine students' transportation needs and receive the funding
3. In determining extraordinary transportation costs, the PSU must consider total prior year transportation expenditures including expenditures from local funds and all other funding sources, as a proportion of total expenditures
4. PSU are required to complete a brief end-of-year report, which will be available annually
5. All project funds are to be spent according to the proposed timeframe by the State
6. Recipients not in compliance will surrender the remaining funds and be required to reimburse their funds if not used appropriately
7. NC Department of Public Instruction (NCDPI) will report each March to the State, as required

### **Administration of Funds & Oversight**

1. The State Coordinator for the Education of Homeless Children and Youth and the State Point of Contact (POC) for Foster Care will work with the finance office to confirm allotments to eligible PSU on annual basis
2. Program needs assessments will include a section specific to the funding source
3. An annual End-of-Year report will be required of the recipients
4. Review of recipient's funds will be included through the desk, on-site, or small group monitoring of the Public School Unit (PSU)

#### 2021-2022SY Approvals for Funding

- There were a total of 74 Public School Units (PSUs) that waived the funding opportunity
- There were 63 applications submitted by PSUs for the funding opportunity
- There were 19 applications from PSUs that reported "0" for identification or did not enter information in their application
- There were 44 applications from PSUs that were eligible for the funding opportunity and were recommended
- State Board of Education provided with the recommendations and provided approvals in March
