

Report to the North Carolina General Assembly

Feminine Hygiene Products Grant Program

SECTION 7.10.(a) The Department of Public Instruction shall establish the Feminine Hygiene Products Grant Program (Program) to assist public school units participating in the Program in providing students with feminine hygiene products at no charge to the student. To the extent funds are made available for the Program, the Department of Public Instruction shall award public school units grants of up to five thousand dollars (\$5,000) on a first-come, first-served basis, and the Department shall prioritize awarding grants to public school units that did not receive an award pursuant to the Program in the previous fiscal year. No public school unit shall receive more than one grant per fiscal year. No later than March 15, 2023, and every year thereafter that funds are made available for the Program, the Department shall report to the Joint Legislative Education Oversight Committee on the public school units receiving grants under the Program, the specific feminine hygiene products purchased with the grant funds, and the impact of the Program on student health and well-being.

INTRODUCTION


The Department of Public Instruction's (DPI) NC Healthy Schools Section of the Office of Academic Standards provided an application to all public school units (PSUs) to apply on a first-come, first-served basis for the Feminine Hygiene Products Grant Program for funding up to \$5,000 to purchase feminine hygiene products. A total of 112 applications were received, with requests in funding amounts ranging from \$500 to \$5,000. With a funding limit of \$250,000, DPI was able to award a total of 66 PSUs with a Feminine Hygiene Products Grant.

The grant awardees indicated that they would use the funding to purchase products ranging from tampons and pads to underwear and educational materials on puberty. The PSUs also noted that the grants would provide much needed support for students to stay in school during the time of their menstrual cycle; make products more accessible to students with transportation constraints and students impacted by natural disasters; provide feminine hygiene supplies for those who cannot afford the expensive products; reduce the stigma associated with menstruation; and offset teacher, staff, and PSU expenses for such products. Many of the awardees indicated that some students rely on their school to provide the feminine hygiene products they need, as their families may not have the financial means to purchase the products.

The following sections outline in greater detail the PSUs that received a grant and the amount they received; the types of products that PSUs indicated they would use the funding to purchase; and how the grant would impact student health and well-being. Appendices are also included to provide additional information on each awarded PSU's application responses and feedback on grant impact.

PSU GRANT RECIPIENTS

Over the course of a week, DPI received 112 applications for the Feminine Hygiene Products Grant Program. Of the 112 applications received, DPI was able to award 66 grants to PSUs from each of the eight State Board of Education (SBE) Regions. Grant awards were distributed to 35 LEAs, 31 Charter schools, and 1 Lab school. The following chart outlines the grant distribution by region (please refer to Appendix A for a detailed map of SBE regions):





PRODUCTS PURCHASED

The PSU grantees indicated that they would use the funding to purchase standard feminine hygiene products, including tampons, pads, menstrual cups, reusable pads, and period underwear. Many grantees indicated that in addition to purchasing the standard feminine hygiene products they would purchase other much needed hygiene products as well, including panty liners, feminine hygiene wipes, washcloths, toiletry and take-home bags containing products, extra undergarments and pants/leggings for accidents, deodorants and soaps, hygiene kits, puberty and menstruation education materials, and heating patches for cramps. In addition to the hygiene products purchased, a few grantees indicated that they would purchase baskets or product dispensers to house products in restrooms and trash receptacles for bathroom stalls. Grantees also commented on the ability to use funding to purchase period underwear, as it is something students ask for and feel more comfortable in, but which the PSU was unable to provide in the past. The following chart outlines which products PSUs said that they would purchase:



IMPACT ON STUDENT HEALTH AND WELL-BEING

Responses to the grant application demonstrated a great need for feminine hygiene products to be available in school. Grant recipients noted that the funding would help to cover costs the district incurs to purchase feminine hygiene products; to alleviate sole reliance on hospitals or community-based organizations, which often are not able to provide enough products to cover students' needs; and to ensure that all schools in a district have supplies on hand when needed. Almost all grantees indicated a great need for student access to feminine hygiene products as they may not have access to them at home or their families may not have the financial

"Duplin County Schools is committed to providing equitable access to supports and resources necessary for students to achieve at their highest level. This grant will allow us to have products on hand (including period underwear which we have not been able to provide before) to promote feminine hygiene. Having the ability to provide these basic necessities for students will enable them to focus on their personal learning and growth without worrying from where throughout the school day, these products can be retrieved. Duplin County is a high need school district in which 100% of all students receive free breakfast and lunch."

means to purchase products themselves. More than half of the grantees indicated that they either have Title I schools in their districts or that many of their students and families are living below the poverty line. For these students and families, feminine hygiene products are an expense they cannot afford or something they lack access to because of transportation constraints, and therefore have to rely on the school to provide these products.

A number of grantees also noted the stigma and embarrassment students experience surrounding menstruation, especially for those who do not have access to supplies and have to miss school during their cycles. Most grantees also noted that an increase in the availability of hygiene products in school would help students stay in school when they are menstruating and would alleviate student anxiety and embarrassment. Other grantees highlighted that students were very excited about the availability of period underwear, as they provide comfort and reduce leakage compared with other traditional products. The following summary points outline in greater specificity awardee comments on how the grant would impact student health and well-being:

"This grant will help to ease the financial burden on parents, staff, and students. Our school district has 89 schools, many of which are located in the Tier 1 poverty area of the city. School social workers and office staff provide feminine hygiene products for students in need using their own funds and constantly seeking donations. This is not included in school budget expenditures. Getting these funds will allow some students not to miss school during menstruation and provides equity in services to students."

- Alleviate financial hardship for both schools, educators, and students
- Remove stigma, anxiety, and embarrassment related to menstruation and period poverty
- Provide much needed support for resource poor areas
- Prevent rationing of hygiene products in schools
- Reduce instance of poor feminine hygiene and health risks, such as infections and reproductive health complications.
- Alleviate access barriers, such as transportation to stores to purchase products
- Improve student mental and physical health, including reducing bullying and supporting school efforts to provide a safe environment that supports the whole child
- Decrease fear of younger students, especially 8-12 years of age, who may begin menstruating and not have the supplies they need
- Increase educational opportunities and academic growth because students can stay in school when they are menstruating
- Increase awareness and education on the importance of maintaining good feminine hygiene practices
- Ability to provide increased access to products throughout the school instead in just one location, including in food pantries, nurse's office, restrooms, and athletic trainer offices for after school sports
- Give districts, schools, and teachers the ability to genuinely meet the need of students when it comes to availability of hygiene products in school
- Empower students to be prepared for the day-to-day of being in and staying in school
- Provide support to the most vulnerable students, including those experiencing homelessness, those displaced due to natural disaster, and those living below the poverty line
- Provide much needed support for families and communities that rely on schools to provide feminine hygiene products to students

"It is imperative that students have access to necessary hygiene products in order for them to effectively engage in learning, particularly our economically-disadvantaged students who are most significantly impacted by this challenge. A sense of belongingness and psychological safety and security are vital to foster a positive school climate, and it is essential that students are able to remain in class, focused on learning, and free from embarrassment or shame...many of our schools augment their supplies through teachers' personal investments or through community partnerships and donations—this grant would enable us to serve a vital need across our district, and eliminate a stressor for both students and school staff." - Winston-Salem/Forsyth County Schools

A complete list of grantee application responses on the impacts of student health and well-being by PSU, as well as additional information on their budget for hygiene products prior to receipt of the grant can be found in Appendix B.

In a six-month post award follow-up survey sent to grantees regarding the grant's impact on student health and well-being, awardees outlined the following impacts to-date:

- Opportunity for school to provide products to students, which it was unable to provide previously
- Availability of enough products to meet student needs, and students are pleased with the quality and type of products purchased
- Able to provide products proactively and have them available to meet immediate student needs
- Improvement in school attendance and self-esteem
- Serve all schools in need of supplies as well as Summer School Programs
- Assisted the school in not limiting how many supplies students can take
- Lessen cost burden for students and their families
- Provision of supplies to younger students who may begin their cycles at school and may not have any supplies they need at school
- Opportunity to provide equal access to feminine hygiene products regardless of cost

"We have been able to purchase period product dispensers and products for our students. We have had so many students tell us how much this means to them that they always have access to supplies needed.


- Providing products directly in restrooms to destigmatize menstruation and reduce missed class time
- Alleviate burdens on the nursing budget, and allowed for nurses to purchase other much needed medical supplies for students
- Decreased student stress around attendance, tardiness, embarrassment related to accidents, and having access to basic needs
- Support McKinney Vento students, children in foster care, and others in accessing hygiene
 products which they would not otherwise be able to afford to improve their hygiene, selfesteem, and confidence

Based on the application responses and needs of the districts, the Feminine Hygiene Products Grant Program provided much needed support for both PSUs and for students, families, and communities. As many grantees indicated, there is a direct link between student academic success and the provision of hygiene products in school. The grant program has helped to support districts and students by removing financial barriers to products and ensuring health and well-being is maintained so that students continue their academic growth.

The DPI continues to receive inquires about the Feminine Hygiene Products Grant Program, including inquires on applying for funding and when or if funding might be available in the future.
