RE: Legislative Report on Grant Matching Funds
(Section 16A.1.(b) of Session Law 2013-360)

DATE: September 24, 2013

Section 16A.1.(b) of Session Law 2013-360 requires that the Department of Public Safety report to the Legislature prior to using funds to provide the state match needed to receive grant funds. Pursuant to Section 16A.1.(b) of Session Law 2013-360, the Department reports the need to expend \$178,902.09 of the \$1,200,000 available to provide the state match for the following grant awards for the 2013-14 fiscal year. In addition, a \$9,295.81 match will be provided from Correction Enterprises' receipts.

Division of Adult Correction and Juvenile Justice

Grant Title: Behavior Modification for Control Status. This grant award provides for the implementation of a Behavior Modification Program for males housed in segregation to modify aggressive/disruptive behavior and equip participants with the skills, knowledge and opportunities needed for transition to the regular prison population and eventually back into the community. The total award is \$104,228.16 with \$78,171.12 from the North Carolina Governor's Crime Commission and the Department of Public Safety will provide the **state match of \$26,057.04**.

Grant Title: Residential Substance Abuse Treatment (RSAT). This award will fund treatment programs for adult male and female offenders at the Dan River Prison Work Farm, the Swannanoa Correctional Center for Women and the Polk Correctional Institution. The total award is \$301,808.00 with \$226,356.00 from the North Carolina Governor's Crime Commission and the Department of Public Safety will provide the **state match of \$75,452.00**.

Grant Title: Mental Health Training for Probation Officers. For this project, the Department will partner with the University of North Carolina at Chapel Hill School of Social Work and the North Carolina Department of Health and Human Services' Division of Mental Health, Developmental Disabilities, and Substance Abuse Services to provide statewide mental health training for all probation officers and to evaluate specialty mental health probation officer training. The total award is \$151,527.00 with \$113,645.25 from the North Carolina Governor's Crime Commission and the Department of Public Safety will provide the **state match of \$37,881.75**.

Grant Title: Reentry Case Management Software. The purpose of this project is to support the purchase of case management software that will enhance the creation of Reentry Councils. The technology related software will assist community service providers who in turn assist offenders. The total award is \$119,490.00 with \$89,617.50 from the North Carolina Governor's Crime Commission and the Department of Public Safety will provide the **state match of \$29,872.50**.

Legislative Report on Grant Matching Fund

Grant Title: Thinking for Change. This project will provide cognitive behavioral training, tools and resources to Correction Enterprises' employees and inmates. The total award is \$37,183.24 with \$27,887.43 from the North Carolina Governor's Crime Commission and the Department of Public Safety Correction Enterprises will provide the **state match of \$9,295.81 from sales receipts which does not impact the general fund.**

Grant Title: The Jumpstart Project. This program seeks to promote successful youth re-entry to school and careers, helping to reduce the North Carolina juvenile recidivism rate. The grant funds a Career Specialist position that provides for career exploration, community outreach and job training activities for youth from a 10-county catchment area. Youth in this program are assigned to the Cabarrus Youth Development Center. The total award is \$106,026.80 with \$96,388 from the North Carolina Governor's Crime Commission and the Department of Public Safety will provide 10 percent **state match of \$9,638.80.**

Division of Administration

Grant Title: State and Local Implementation Grant Program. This program is designed to assist regional, state, local, and tribal government entities to plan for a nationwide public safety broadband network known as the First Responder Network Authority or FirstNet. The total three year award is \$4,003,926 with \$3,203,141 from the National Telecommunications and Information Administration of the U.S. Commerce Department of Commerce and the Department of Public Safety will provide the **state match of \$800,785 of which approximately \$500,000 will be cash in year two and three of the award. The match for 2013-14 is expected to be in-kind.**
