Juvenile Justice: 2023-2024 3rd Quarter

The following data is based on available information for the period starting July 1, 2023, and ending on September 30, 2023.

1. The percentage of the total juvenile offenders requiring hospitalization or hospital services who receive that treatment at each hospital.

During this quarter, there were 23 juveniles from the 3rd quarter of 2023 with billing claims for treatment or diagnostics at a community hospital or affiliated setting with 4 claims submitted for payment during the 3rd quarter of 2023.

All hospitals comply with the mandated rates of two times Medicaid rate or seventy percent of prevailing rates. All claims were processed in a timely manner by PBGA.
