

# INTRODUCTION

The North Carolina Legislative Research Commission, as an interim study organization of the General Assembly, studies issues as directed by the preceding legislative session or the Commission Chairmen. These studies are done by assigned interim study committees. Study committees may find that legislation is necessary to address the needs found. These committees endorse various draft bills; the complete text of these bills may be found in the individual interim study committee reports. The purpose of this report is to indicate the results of the legislative recommendations of the committees which were to report to the 1989 General Assembly.

In the "Activity Summaries by Study" section, legislative recommendations are grouped by committee. The recommendations are further divided into those bills which were not introduced and those which were introduced. Bills introduced and ratified are designated by **bold faced type.** Bills which were introduced and not ratified carry no special type of designation.

While the text of each introduced bill is the same as the text of each study committee recommendation, the text of the ratified bill may differ from the study committee recommendation. When companion bills were introduced in both houses based on single study committee recommendations, the companion bills are counted as one bill for statistical purposes. If one bill was ratified and one was not, this counts as one ratification; similarly, if neither bill was ratified, this counts as one unratified bill.

In the "Statistics" section of this report the numbers of bills recommended; recommended but not introduced; recommended and introduced; ratified; and not ratified are listed by study committee, then totaled. The Legislative Research Commission study committees recommended 118 bills to the 1989 Session. Of the 118 bills recommended, 98% (116 of 118) bills were actually introduced. Of the introduced bills, 61% (44 of 72) were ratified in some form. This compares with a 21.4% success rate for public bills during the 1989 and 1990 legislative sessions.<sup>1</sup> To compare these figures with the 1987 Session of the General Assembly, of the bills recommended by the study committees, 84% (76 of 90) were actually introduced. Of those introduced in the 1987 Session, 70% (53 of 76) were ratified in some form. The success rate for 1987-1988 public bills was 31.3%.

<sup>1</sup> The 61% ratification rate for bills introduced by study committees is higher than the 21.4% ratification rate of public bills. During the 1989 and 1990 legislative sessions, a total of 4045 bills and joint resolutions were introduced, not including simple resolutions. During the same period, 1158 bills and resolutions were actually ratified. The success rate for public bills is obtained by first finding the total number of public bills. The total number of public bills from the total number of bills and joint resolutions. To this number, we add the 107 bills, which although not ratified, were incorporated by reference in the umbrella studies. For the 1989 and 1990 legislative sessions, 3353 public bills were introduced. Of those, 716 public bills were ratified or incorporated by reference. When 716 is divided by 3353, the result is a success rate of 21.4%.

# Control of Development Around Small Public Water Supply Reservoirs; State Permitting of Septic Tank Systems <sup>1</sup>

PROVIDE THAT A PERSON WHO HAS A DEGREE IN ENVIRONMENTAL HEALTH FROM AN ACCREDITED UNIVERSITY OR COLLEGE NEEDS ONLY ONE YEAR OF EXPERIENCE TO SATISFY THE EDUCATION AND EXPERIENCE REQUIREMENTS FOR A REGISTERED SANITARIAN.

PROVIDE THAT A MANDATORY CONTINUING EDUCATION PROGRAM FOR SANITARIANS WHO ADMINISTER THE RULES REGARDING SANITARY SEWAGE SYSTEMS SHALL BE DEVELOPED BY THE DEPARTMENT OF HUMAN RESOURCES. ESTABLISH A CERTIFICATION PROGRAM FOR SANITARY SEWAGE SYSTEM CONTRACTORS AND TO REQUIRE CERTIFICATION OF SANITARY SEWAGE CONTRACTORS WHO INSTALL, CONSTRUCT, REPAIR, OR MAINTAIN ALTERNATIVE OR NONCONVENTIONAL SANITARY SEWAGE SYSTEMS.

PROVIDE THAT ONE MEMBER OF EACH LOCAL BOARD OF HEALTH SHALL BE A PROFESSIONAL ENGINEER OR CERTIFIED SANITARY SEWAGE SYSTEM CONTRACTOR.

MAKE ADDITIONAL REVIEW AND APPEAL PROCEDURES AVAILABLE TO CONTEST THE DENIAL OF AN IMPROVEMENT PERMIT.

PROVIDE THAT A WRITTEN SITE EVALUATION NOTIFICATION OF REVIEW AND APPEAL OPTIONS SHALL BE GIVEN UPON DENIAL OF AN IMPROVEMENT PERMIT.

EXTEND THE PERIOD OF TIME FOR WHICH AN IMPROVEMENT PERMIT IS VALID AND TO INDICATE THE TERM AND LIMITATIONS NOTICEABLY ON THE APPLICATION AND PERMIT.

DIRECT THE COMMISSION FOR HEALTH SERVICES TO MODIFY THE RULE CONCERNING SITES WITH EXISTING FILL.

PROVIDE THAT AEROBIC SYSTEMS MAY BE PERMITTED IN NORTH CAROLINA.

APPROPRIATE FUNDS TO THE DEPARTMENT OF HUMAN RESOURCES FOR RESEARCH AND DEVELOPMENT OF ON-SITE SEWAGE SYSTEMS, TO ASSIST LOW INCOME PEOPLE TO REPAIR FAILING SEPTIC TANKS, AND TO PROVIDE CONTINUING EDUCATION FOR SANITARIANS.

APPROPRIATE FUNDS FOR RESEARCH AND DEVELOPMENT OF WASTEWATER MANAGEMENT SYSTEMS.

APPROPRIATE FUNDS FOR THE RESEARCH AND DEVELOPMENT OF QUANTITATIVE METHODS TO EVALUATE HIGH WATER TABLE SOILS FOR ON-SITE WASTE TREATMENT.

ESTABLISH A STATEWIDE FEE SCHEDULE FOR IMPROVEMENT PERMITS.

PROVIDE FOR THE PERMITTING OF INNOVATIVE, EXPERIMENTAL, OR PROPRIETARY SYSTEMS.

#### **Disadvantaged Business Contracts Financed by State Funds**

The Committee made a number of recommendations but proposed no legislation for consideration by the 1989 Session.

#### Gerontology

REQUIRE THAT THE DIVISION OF AGING PROVIDE FOR THE COORDINATION OF ALL EXISTING DATA REGARDING THE ELDERLY AND TO REQUIRE THAT ALL STATE AGENCIES AND ENTITIES POSSESSING SUCH DATA COOPERATE WITH THE DIVISION. (HB 70 - Wiser, Ratified - Ch. 695)
