

After lunch, the Committee reconvened at 1:45 p.m. at the Morehead City Train Depot for a full Committee meeting. ### **April 4, 2016**

The eighth meeting of the Committee was held April 4, 2016 in the Legislative Office Building.

Each of the four Subcommittees of the Committee met separately, beginning at 9:00 a.m., in Room 544 of the Legislative Office Building. Each Subcommittee reviewed and discussed its work to date. The Secondary Roads Subcommittee recommended two bill drafts to the full Committee, with the following short titles: (1) Adjusting Unpaved Roads Funding Expenditures, and (2) Ferry System Stabilization Act. In addition, the Secondary Roads Subcommittee made a recommendation that the General Assembly consider increased funding for unpaved secondary roads. The Ports/Rail Subcommittee made a recommendation that State Ports are of critical importance, and need further investment and study.

The full Committee convened at 2:00 p.m. in Room 544 of the Legislative Office Building. Each Subcommittee chair gave a report of the Subcommittee's work to date.

The Committee approved the Subcommittee recommendations listed above, with the following changes: the Committee amended the Ferry System Stabilization Act bill draft to eliminate tolls on all ferries and increase the yearly appropriation from the Highway Fund to the Ferry Division. The Committee also approved a third bill draft, short title: Repeal Light Rail Funding Cap. All three bill drafts are attached to this report, beginning on page 13.

The Committee then approved this report, and adjourned, with plans to reconvene following the 2016 Session of the General Assembly, as authorized by letter of the Speaker of the House of Representatives, dated March 8, 2016, and included in this report on page 31.

## RECOMMENDED LEGISLATION

### Summaries of Recommended Legislation

**2015-MLz-245**: Current law provides that the Department of Transportation (DOT) shall expend funds allocated for the paving of unpaved secondary roads based on a statewide prioritization. This act adjusts that expenditure scheme as follows:

- The DOT shall expend 50% of the funds allocated for the paving of unpaved secondary roads based on a statewide prioritization.
- The DOT shall expend the remaining funds equally among the 14 Highway Divisions for the paving of secondary roads within the particular Highway Division based on the same statewide prioritization.

**2015-MLza-256**: Current law authorizes the Board of Transportation to toll ferry routes. Currently, the following routes are untolled:

- Bayview - Aurora
- Cherry Branch – Minnesott Beach
- Currituck – Knotts Island
- Hatteras – Ocracoke

This act repeals the Board of Transportation's authority to establish tolls on ferry routes and eliminates the current tolls on all tolled ferry routes. In addition, this act appropriates from the Highway Fund to the Ferry Division \$13.85 million in recurring funds to be used for the rehabilitation and replacement of vessels and infrastructure at the North Carolina State Shipyard and the system terminals.

**2015-MLz-253**: Current law provides that, on a per project basis, no more than \$500,000 in funds subject to the Transportation Investment Strategy Formula may be expended for a light rail transit system project. This act repeals that limitation.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** G.S. 136-44.2D reads as rewritten:

8 "**§ 136-44.2D. Secondary unpaved road paving program.**

9 The Department of Transportation shall expend fifty percent (50%) of the funds  
10 allocated to the paving of unpaved secondary roads for the paving of unpaved secondary  
11 roads based on a statewide prioritization. The Department shall expend the remainder of  
12 the funds equally among the 14 Highway Divisions for the paving of unpaved  
13 secondary roads within each Highway Division based on the same statewide  
14 prioritization. The Department shall pave the eligible unpaved secondary roads that  
15 receive the highest priority ranking within this statewide prioritization. Nothing in this  
16 subsection shall be interpreted to require the Department to pave any unpaved  
17 secondary roads that do not meet secondary road system addition standards as set forth  
18 in G.S. 136-44.10 and G.S. 136-102.6. The Highway Trust Fund shall not be used to  
19 fund the paving of unpaved secondary roads."

20 **SECTION 2.** This act becomes effective July 1, 2016, and applies to funds  
21 allocated on or after that date.

9 The General Assembly of North Carolina enacts:

10 SECTION 1. G.S. 136-82 reads as rewritten:

11 "§ 136-82. Department of Transportation to establish and maintain ferries.

12 (a) Powers of Department. – The Department of Transportation is vested with  
13 authority to provide for the establishment and maintenance of ferries connecting the  
14 parts of the State highway system, whenever in its discretion the public good may  
15 require, and shall prescribe and collect tolls on the ferry routes as established by the  
16 Board of Transportation following the procedures set forth in this section. require.

17 (b) ~~Establishment of Tolling.~~ The Board of Transportation may establish tolls  
18 on any untolled ferry route as set forth in this subsection. Prior to establishing tolls on  
19 an untolled ferry route, the Board of Transportation must receive a resolution approved  
20 by the Transportation Advisory Committee of each affected local transportation  
21 planning organization requesting tolls on that route. No later than March 1, 2014, the  
22 Department shall hold a separate public hearing in the geographic area of each untolled  
23 ferry route and invite each affected local transportation planning organization. At the  
24 public hearing, the Department shall present an explanation of the toll setting  
25 methodology, the impact of tolling on the availability of funding for other local  
26 transportation priorities, and the minimum and maximum toll rates. After the public  
27 hearing, an affected local transportation planning organization may consider and adopt a  
28 ferry tolling resolution. The Board of Transportation shall adopt the toll at its next  
29 regularly scheduled meeting after receipt of the ferry tolling resolutions required by this  
30 subsection. The Department shall collect the toll as soon as is feasible following its  
31 adoption, but in no case more than 180 days after adoption of the toll. The establishment  
32 of tolls by the Board of Transportation pursuant to the authority granted in this section

1 shall be exempt from the provisions of Chapter 150B of the General Statutes. For  
2 purposes of this section, "affected local transportation planning organization" means any  
3 Metropolitan Planning Organization or Rural Transportation Planning Organization  
4 with geographic jurisdiction over any part of an untolled ferry route, and "untolled ferry  
5 route" means any ferry route for which no tolls were in effect as of June 30, 2013.

6 (c) — Revisions of Tolls. — The Department of Transportation shall report to the  
7 Fiscal Research Division, the Joint Legislative Transportation Oversight Committee,  
8 and all affected local transportation planning organizations 30 days prior to any change  
9 in toll rates or change in the toll setting methodology by the Board of Transportation.

10 (d) — Use of Toll Proceeds. — The Department of Transportation shall credit the  
11 proceeds from tolls collected on North Carolina Ferry System routes and certain receipts  
12 generated under subsection (f) of this section to reserve accounts within the Highway  
13 Fund for each of the Highway Divisions in which system terminals are located and fares  
14 are earned. For the purposes of this subsection, fares are earned based on the terminals  
15 from which a passenger trip originates and terminates. Commuter pass receipts shall be  
16 credited proportionately to each reserve account based on the distribution of trips  
17 originating and terminating in each Highway Division. The proceeds credited to each  
18 reserve account shall be used exclusively for prioritized North Carolina Ferry System  
19 ferry passenger vessel replacement projects in the Division in which the proceeds are  
20 earned. Proceeds may be used to fund ferry passenger vessel replacement projects or  
21 supplement funds allocated for ferry passenger vessel replacement projects approved in  
22 the Transportation Improvement Program.

24 (f) Authority to Generate Certain Receipts. — The Department of Transportation,  
25 notwithstanding any other provision of law, may operate or contract for the following  
26 receipt-generating activities and, except as otherwise provided in subsection (f1) of this  
27 section, use the proceeds for ferry passenger vessel replacement projects in the manner  
28 set forth in subsection (d) of this section: exclusively for prioritized North Carolina Ferry  
29 System ferry passenger vessel replacement projects in the Division in which the  
30 proceeds are earned:

- 31 (1) Operation of, concessions on the ferries and at ferry facilities to  
32 provide to passengers on the ferries food, drink, and other  
33 refreshments, personal comfort items, Internet access, and souvenirs  
34 publicizing the ferry system.
- 35 (2) Sponsorships, including, but not limited to, the sale of naming rights to  
36 any ferry vessel, ferry route, or ferry facility.
- 37 (3) Advertising on or within any ferry vessel or at any ferry facility,  
38 including, but not limited to, display advertising and advertising  
39 delivered to passengers through the use of video monitors, public  
40 address systems installed in passenger areas, and other electronic  
41 media.
- 42 (4) Any other receipt-generating activity not otherwise forbidden by  
43 applicable law pertaining to public health or safety.

44 Proceeds may be used to fund ferry passenger vessel replacement projects or  
45 supplement funds allocated for ferry passenger vessel replacement projects approved in

1 the Transportation Improvement Program. The Department may issue rules to  
2 implement this subsection.

3 (f1) Use of Receipts Generated From Shipyard. – The Department of  
4 Transportation shall credit the proceeds from receipts generated under subsection (f) of  
5 this section from activities performed by the North Carolina State Shipyard to a reserve  
6 account within the Highway Fund to be used exclusively for improvements to the  
7 Shipyard, including equipment and associated infrastructure. ~~Notwithstanding the~~  
8 ~~restrictions on the use of proceeds set forth in subsections (d) and (f) of this section, the~~  
9 ~~Department may use a proportional amount of the proceeds credited to each reserve~~  
10 ~~account described in subsection (d) of this section to replace or repair equipment in~~

13 (g) Confidentiality of Personal Information. – Identifying information obtained  
14 by the Department related to operation of the ferry system is not a public record under  
15 Chapter 132 of the General Statutes and is subject to the disclosure limitations in 18  
16 U.S.C. § 2721 of the federal Driver's Privacy Protection Act. The Department shall  
17 maintain the confidentiality of all information required to be kept confidential under 18  
18 U.S.C. § 2721(a), as well as any financial information, transaction history, and  
19 information related to the collection of a ~~toll~~ or user fee from a person, including, but  
20 not limited to, photographs or other recorded images or automatic vehicle identification  
21 or driver account information generated by radio-frequency identification or other  
22 electronic means. The Department may use identifying information only for purposes of  
23 collecting and enforcing ~~tolls.~~ user fees. Nothing in this section is intended to limit the  
24 right of any person to examine that person's own account information, or the right of  
25 any party, by authority of a proper court order, to inspect and examine identifying  
26 information."

27 **SECTION 2.** G.S. 7A-312(a) reads as rewritten:

28 "(a) A juror in the General Court of Justice including a petit juror, or a coroner's  
29 juror, but excluding a grand juror, shall receive twelve dollars (\$12.00) for the first day  
30 of service and twenty dollars (\$20.00) per day afterwards, except that if any person  
31 serves as a juror for more than five days in any 24-month period, the juror shall receive  
32 forty dollars (\$40.00) per day for each day of service in excess of five days. A grand  
33 juror shall receive twenty dollars (\$20.00) per day. A juror required to remain overnight  
34 at the site of the trial shall be furnished adequate accommodations and subsistence. If  
35 required by the presiding judge to remain in a body during the trial of a case, meals shall  
36 be furnished the jurors during the period of sequestration. Jurors from out of the county  
37 summoned to sit on a special venire shall receive mileage at the same rate as State  
38 employees. ~~Persons summoned as jurors shall be exempt during their period of service~~  
39 ~~from paying a ferry toll required under G.S. 136-82 to travel to and from their homes~~  
40 ~~and the site of that service."~~

41 **SECTION 3.** G.S. 136-189.11(b)(8) is repealed.

42 **SECTION 4.** The Board of Transportation shall cease collecting ferry tolls  
43 on the effective date of this act and shall take action as expeditiously as possible to  
44 repeal its regulations implementing ferry tolls. Prepaid tolls or commuter pass payments  
45 received by the Department of Transportation for ferry trips on or after the effective  
46 date of this act shall be refunded or, in the case of prepaid commuter passes, partially

1 refunded based on the proportion of the time period covered by the commuter pass for  
2 which tolls were in effect. Any funds remaining in the reserve accounts described in  
3 G.S. 136-82(d) as of the effective date of this act shall be used for the rehabilitation and  
4 replacement of vessels and infrastructure at the North Carolina State Shipyard and the  
5 system terminals."

6           **SECTION 5.** Beginning in the 2016-2017 fiscal year, there is appropriated  
7 from the Highway Fund to the Ferry Division of the Department of Transportation  
8 thirteen million eight hundred fifty thousand dollars (\$13,850,000) in recurring funds to  
9 be used for the rehabilitation and replacement of vessels and infrastructure at the North  
10 Carolina State Shipyard and the system terminals.

11           **SECTION 6.** This act becomes effective July 1, 2016.

**Section 10.** The Committee may submit an interim report on the results of its findings, including any proposed legislation, to the members of the House of Representatives at any time. The Committee may submit a final report on the results of its findings, including any proposed legislation to the members of the House of Representatives prior to the convening of the Short Session of the 2015 General Assembly. Reports shall be submitted by filing a copy of the report with the Office of the Speaker of the House of Representatives, the House principal Clerk, and the Legislative Library. The Committee terminates upon the convening of the Short Session of the 2015 General Assembly or upon the filing of its final report, whichever occurs first.
