A BILL TO BE ENTITLED

AN ACT TO ENHANCE THE EDUCATIONAL REQUIREMENTS FOR CERTIFIED PUBLIC ACCOUNTANTS.

The General Assembly of North Carolina enacts:

Section 1. Effective January 1, 1997, G.S. 93-12(5) reads as rewritten:

"(5) To issue certificates of qualification admitting to practice as certified public accountants, each applicant who, having the qualifications herein specified, shall have passed an examination to the satisfaction of the Board, in 'accounting theory,' 'accounting practice,' 'accounting,' 'auditing,' 'business law,' and other related subjects.

~~From and after July 1, 1961, any person shall be~~ A person is eligible to take the examination given by the Board, or to receive a certificate of qualification to practice as a certified public accountant, who is a citizen of the United States or has declared his intention of becoming a citizen or is a resident alien, and has been domiciled in or resided for at least four months within the State of North Carolina immediately prior to the filing of an application to take the examination or to receive a certificate of qualification, is 18 years of age or over, and is of good moral character, and submits evidence satisfactory to the Board that:

- a. He holds a bachelor's degree from a college or university accredited by one of the regional accrediting associations or from a college or university determined by the Board to have standards substantially equivalent to a regionally accredited institution, and

- 1 b. His degree studies included a concentration in accounting as
2 defined by the Board or that he supplemented his degree studies
3 with courses that the Board determines to be substantially
4 equivalent to a concentration in accounting, ~~accounting, and~~
5 e. ~~Satisfactory evidence of the completion of two years in an~~
6 ~~accredited college or university or its equivalent with a~~
7 ~~concentration in accounting as defined by the Board and two~~
8 ~~years experience in the practice of public accountancy under the~~
9 ~~direct supervision of a certified public accountant, in addition to~~
10 ~~other experience requirements in this section, may be~~
11 ~~substituted for a bachelor's degree.~~

12 Provided, however, the Board may, in its discretion, waive
13 the education requirement of any candidate if the Board is
14 satisfied from the result of a special written examination given
15 the candidate by the Board to test his educational qualifications
16 that he is as well ~~equipped, educationally,~~ qualified as if he met
17 the education requirements specified above. The Board may
18 provide by regulation for the general scope of such
19 examinations and may obtain such advice and assistance as it
20 deems appropriate to assist it in preparing, administering and
21 grading such special examinations.

22 Such applicant, in addition to passing the examination given
23 by the Board, shall have the endorsement as to his eligibility of
24 three certified public accountants who currently hold licenses in
25 any state or territory of the United States or the District of
26 Columbia and shall have had either:

- 27 a. Two years experience in the field of accounting under the direct
28 supervision of a certified public accountant who currently holds
29 a valid license in any state or territory of the United States or
30 the District of Columbia, or
31 b. Five years experience teaching accounting in a four-year
32 college or university accredited by one of the regional
33 accrediting associations or in a college or university determined
34 by the Board to have standards substantially equivalent to a
35 regionally accredited institution; or
36 c. Five years experience in the field of accounting; or five years
37 experience teaching college transfer accounting courses at a
38 community college or technical institute accredited by one of
39 the regional accrediting associations; or
40 d. Any combination of such experience determined by the Board
41 to be substantially equivalent to the foregoing.

42 A Master's or more advanced degree in accounting, tax law,
43 economics, business administration, or the equivalent thereof, or a law
44 degree with emphasis in taxation or accounting from an accredited

1 college or university may be substituted for one year of experience.
2 The Board may permit persons otherwise eligible to take its
3 examinations and withhold certificates until such person shall have had
4 the required experience."

5 Sec. 2. Effective January 1, 2001, G.S. 93-12(5), as amended by Section 1 of
6 this act, reads as rewritten:

26 a1. The candidate has completed a total of 150 college semester
27 hours which include a bachelor's degree at a college or
28 university determined by the Board to have standards
29 substantially equivalent to a regionally accredited institution,
30 and

31 b. ~~His degree studies included a concentration in accounting as~~
32 ~~defined by the Board or that he supplemented his degree studies~~
33 ~~with courses that the Board determines to be substantially~~
34 ~~equivalent to a concentration in accounting.~~

35 b1. The candidate's total postsecondary school education included a
36 concentration in accounting, as defined by the Board, or degree
37 studies were supplemented with courses determined by the
38 Board to be substantially equivalent to a concentration in
39 accounting.

40 Provided, however, the Board may, in its discretion, waive the
41 education requirement of any candidate if the Board is satisfied from
42 the result of a special written examination given the candidate by the
43 Board to test his educational qualifications that he is as well qualified
44 as if he met the education requirements specified above. The Board

1 may provide by regulation for the general scope of such examinations
2 and may obtain such advice and assistance as it deems appropriate to
3 assist it in preparing, administering and grading such special
4 examinations.

5 Such applicant, in addition to passing the examination given by the
6 Board, shall have the endorsement as to his eligibility of three certified
7 public accountants who currently hold licenses in any state or territory
8 of the United States or the District of Columbia and shall have had
9 either:

- 10 a. Two years experience in the field of accounting under the direct
11 supervision of a certified public accountant who currently holds
12 a valid license in any state or territory of the United States or
13 the District of Columbia, or
14 b. Five years experience teaching accounting in a four-year
15 college or university accredited by one of the regional
16 accrediting associations or in a college or university determined
17 by the Board to have standards substantially equivalent to a
18 regionally accredited institution; or
19 c. Five years experience in the field of accounting; or five years
20 experience teaching college transfer accounting courses at a
21 community college or technical institute accredited by one of
22 the regional accrediting associations; or
23 d. Any combination of such experience determined by the Board
24 to be substantially equivalent to the foregoing.

25 A Master's or more advanced degree in accounting, tax law,
26 economics, business administration, or the equivalent thereof, or a law
27 degree with emphasis in taxation or accounting from an accredited
28 college or university may be substituted for one year of experience.
29 The Board may permit persons otherwise eligible to take its
30 examinations and withhold certificates until such person shall have had
31 the required experience."

32 Sec. 3. Section 1 of this act becomes effective January 1, 1997. Section 2 of
33 this act becomes effective January 1, 2001. The remainder of this act is effective upon
34 ratification.
