- Funds not expended or encumbered for these purposes shall revert to the General Fund at the end of the 1994-95 fiscal year.
 - Sec. 3. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources the sum of one million dollars (\$1,000,000) for the 1993-94 fiscal year to fund various coastal dredging projects.
 - Sec. 4. Beginning October 1, 1993, the Department shall make quarterly reports on the use of these funds to the Joint Legislative Commission on Governmental Operations, the Fiscal Research Division, and the Office of State Budget and Management. Each report shall include:
 - (1) All projects listed in this act;
 - (2) The estimated cost of each project;
 - (3) The date that work on each project began or is expected to begin;
 - (4) The date that work on each project was completed or is expected to be completed; and
 - (5) The actual cost of each project.
- The quarterly reports shall also show those projects advanced in schedule, those projects delayed in schedule, and an estimate of the amount of funds expected to revert to the General Fund.
- 19 Sec. 5. This act becomes effective July 1, 1993.
