1 A BILL TO BE ENTITLED  
2 AN ACT TO FURTHER EXTEND EXPIRING PROVISIONS.

3 The General Assembly of North Carolina enacts:

4  
5 **SALARIES/GOVERNMENT EMPLOYEES**

6 Section 1. Section 2 of Chapter 358 of the 1995 Session Laws reads as  
7 rewritten:

8 "Sec. 2. (a) The salary schedules and specific salaries established by or under  
9 Sections 7.1, 7.2, 7.3, 7.4, 7.5, 7.6, 7.7, 7.9(a), 7.9(b), 7.10, 7.11, 7.12, 7.13, 19.6, or 19.7  
10 of Chapter 769 of the 1993 Session Laws shall remain until ~~July 14,~~ July 21, 1995, at the  
11 level set by or under those sections as of June 30, 1995.

12 (b) No person may receive a salary increase under G.S. 7A-102(c), 126-7 or 20-  
13 187.3(a) prior to ~~July 14,~~ July 21, 1995. No State employee or officer may prior to ~~July~~  
14 ~~14,~~ July 21, 1995, receive a merit increase or annual increment. No employee or officer  
15 subject to the teacher salary schedule or the school-based administrator salary schedule  
16 shall receive an increment until ~~July 14,~~ July 21, 1995."

18 **CONTINUE MEDIATED SETTLEMENT PILOT**

1           Sec. 2. (a) G.S. 7A-38(o), as amended by Section 3 of Chapter 358 of the 1995  
2 Session Laws, reads as rewritten:

3           "(o) Report on pilot program. The Administrative Office of the Courts shall file a  
4 written report with the General Assembly on the evaluation of the pilot program on or  
5 before May 1, 1995. The pilot program shall terminate on ~~July 14,~~ July 21, 1995."

6           (b) Section 3(b) of Chapter 358 of the 1995 Session Laws reads as rewritten:

7           "(b) Notwithstanding the provisions of G.S. 7A-38(n), the Administrative Office of  
8 the Courts may use funds available to the Judicial Department from July 1, 1995, to ~~July~~  
9 ~~14,~~ July 21, 1995, for the purpose of operating the pilot program."

### 11 **EXTEND THE SUNSET OF THE STATUTE PERMITTING PRIVATE** 12 **CONTRACT PARTICIPATION BY THE DEPARTMENT OF** 13 **TRANSPORTATION**

14           Sec. 3. Section 2 of Chapter 860 of the 1987 Session Laws, as amended by  
15 Section 1 of Chapter 749 of the 1989 Session Laws, Section 1 of Chapter 272 of the 1991  
16 Session Laws, Section 2 of Chapter 183 of the 1993 Session Laws, and Section 5 of  
17 Chapter 358 of the 1995 Session Laws reads as rewritten:

18           "Sec. 2. This act is effective upon ratification and shall expire ~~July 14,~~ July 21,  
19 1995."

### 21 **EXTEND PUBLIC HEALTH STUDY COMMISSION**

22           Sec. 4. Section 8.1 of Chapter 771 of the 1993 Session Laws as amended by  
23 Section 6 of Chapter 358 of the 1995 Session Laws reads as rewritten:

24           "Sec. 8.1. This act is effective upon ratification. Part II of this act is repealed on ~~July~~  
25 ~~14,~~ July 21, 1995."

### 27 **EXTEND BEAVER DAMAGE CONTROL**

28           Sec. 5. Subsection (h) of Section 69 of Chapter 1044 of the 1991 Session  
29 Laws, as amended by Section 111 of Chapter 561 of the 1993 Session Laws, by Section  
30 27.3 of Chapter 769 of the 1993 Session Laws, and Section 7 of Chapter 358 of the 1995  
31 Session Laws reads as rewritten:

32           "(h) Subsections (a) through (d) of this section expire ~~July 14,~~ July 21, 1995."

### 34 **EXTEND THE SUNSET FOR THE MEDIATION PROGRAM FOR THE** 35 **INDUSTRIAL COMMISSION**

36           Sec. 6. (a) Section 5 of Chapter 399 of the 1993 Session Laws as amended by  
37 Section 8 of Chapter 358 of the 1995 Session Laws reads as rewritten:

38           "Sec. 5. Section 3 of this act is effective upon ratification. Sections 1, 2, and 4 of this  
39 act become effective October 1, 1993, only if the General Assembly appropriates funds to  
40 implement the purpose of these sections, expire ~~July 14,~~ July 21, 1995, and apply to  
41 claims pending on or filed after the effective date."

43           (b) Section 5.4 of Chapter 679 of the 1993 Session Laws as amended by Section 8  
of Chapter 358 of the 1995 Session Laws reads as rewritten:

1 "Sec. 5.4. Subsection (c) of G.S. 97-80 shall expire ~~July 14,~~ July 21, 1995, in  
2 accordance with the provisions of Chapter 399 of the 1993 Session Laws, unless the  
3 General Assembly amends Chapter 399 of the 1993 Session Laws to provide otherwise."

4 Sec. 7. Section 3 of Chapter 358 of the 1995 Session Laws reads as rewritten:

5 "Sec. 9. This act is effective upon ratification, but Sections 2 and 3 and Sections 5  
6 through 8 expire ~~July 14,~~ July 21, 1995."

7 Sec. 8. This act is effective upon ratification.
