1 A JOINT RESOLUTION HONORING THE LIFE AND MEMORY OF THE LATE
2 JAMES MARSHALL HALL, FORMER MEMBER OF THE GENERAL
3 ASSEMBLY.

4 Whereas, James Marshall Hall was born in King on August 6, 1922, one of
5 three children of Raleigh F. Hall and Hattie Fowler Hall; and

6 Whereas, James Marshall Hall graduated from King High School in 1940;
7 and

8 Whereas, James Marshall Hall was a veteran of the United States Army,
9 serving his country during World War II from 1942 to 1946; and

10 Whereas, James Marshall Hall had several vocations; he engaged in farming,
11 served as an insurance agent for 18 years, and worked for the Division of Motor
12 Vehicles for seven years; and

13 Whereas, James Marshall Hall married Melba Covington Hall on January 24,
14 1946, and they had three children, Barry, Bruce, and Emily Hall; and

15 Whereas, James Marshall Hall devoted 38 years of his life to little league
16 baseball, enriching the lives of many young children in his community; and

17 Whereas, for a number of years, James Marshall Hall served as President of
18 King Little League Baseball, as President of the North Carolina Little League Baseball
19 Association, as a member of the Southern Region Tournament Advisory Board for

1 Little League Baseball, and as District Administrator of Little League Baseball, Inc.;

2 and

3 Whereas, James Marshall Hall was active in the American Legion and was a
4 member of the King Lions Club, of which he served as treasurer from 1968 to 1972; and

5 Whereas, James Marshall Hall was an active member of the Republican
6 Party; and

7 Whereas, James Marshall Hall represented Stokes County with distinction as
8 a member of the House of Representatives during the 1973 and 1985 Sessions of the
9 General Assembly; and

10 Whereas, James Marshall Hall was a member of the Mount Olive Baptist
11 Church in King; and

12 Whereas, James Marshall Hall will be remembered by all who knew him as a
13 loving and devoted family man; and

14 Whereas, James Marshall Hall died on July 7, 1994; and

15 Whereas, James Marshall Hall is survived by his children, Barry Hall, Bruce
16 Hall, and Emily Southern, four grandchildren, and one great-grandchild;

17 Now, therefore, be it resolved by the House of Representatives, the Senate concurring:

18 Section 1. The General Assembly honors the life and memory of its former
19 member, James Marshall Hall, and expresses its gratitude for his service to the people of
20 North Carolina.

21 Sec. 2. The General Assembly expresses its deep sorrow to the family and
22 friends of James Marshall Hall for the loss of a beloved father, grandfather, and a true
23 friend.

24 Sec. 3. The Secretary of State shall transmit a certified copy of this resolution
25 to the family of James Marshall Hall.

26 Sec. 4. This resolution is effective upon ratification.
