A BILL TO BE ENTITLED

1 AN ACT TO INCREASE THE SIZE OF THE BOARD OF COMMISSIONERS OF
2 EDGECOMBE COUNTY FROM FIVE TO SEVEN MEMBERS AND PROVIDE
3 FOR THE ELECTORAL DISTRICTS.

5 The General Assembly of North Carolina enacts:

6 Section 1. Effective the first Monday in December 1996, the Board of
7 Commissioners of Edgecombe County consists of seven members.

8 Sec. 2. For the purpose of nominating and electing members of the county
9 board of education, Edgecombe County is divided into seven districts, each of which
10 shall nominate and elect one member. The qualified voters of each district established by
11 this act shall nominate candidates and elect a member who resides in that district for the
12 seat apportioned to that district.

26 Sec. 4. In 1996, four members shall be elected from Districts 1, 2, 3, and 4 for
27 terms of 4 years.

28 Sec. 5. In 1998 and quadrennially thereafter, three members shall be elected
29 from Districts 5, 6, and 7 for terms of four years.

30 Sec. 6. This act prevails over any act, public or local, to the extent of the
31 conflict.

32 Sec. 7. This act is effective upon ratification. This act is subject to
33 preclearance by the United States Attorney General under section 5 of the Voting Rights
34 Act of 1965.
