Guy was active in numerous civic and fraternal organizations 4 in his community, serving as a member of the Loyal Order of the Moose and Jacksonville 5 Toastmasters, President of the Jacksonville Rotary Club, President of the Onslow County 6 Chapter of the American Cancer Society, Campaign Chair of the American Red Cross Society, founder of the Jacksonville Municipal Court, and founder of the First Biracial 7 8 Committee in the City of Jacksonville; and 9 Whereas, A. D. Guy also made contributions as a member of the Onslow 10 Memorial Hospital Authority, Board of Directors of the North Carolina League of Municipalities, Board of Directors of the Home Federal Savings and Loan Association, 11 12 Board of Directors of the North Carolina Retail Merchants Association, Governor's Committee of Mayor's Co-Operating Committee, Atlantic State Marine Fisheries 13 14 Commission, and the Committee on Commerce, Labor, and Regulation of the National 15 Conference of State Legislatures State-Federal Assembly; and Whereas, A. D. Guy was a faithful member of the Trinity United Methodist 16 17 Church, serving on the Board of Trustees, the Administrative Board, the Fund Raising 18 Campaign for Christian Higher Education, and as a member of the Staff Parish Relations Committee; and 19 20 Whereas, A. D. Guy was highly respected by his colleagues and the members 21 of his community; and 22 Whereas, A. D. Guy died on March 14, 1998; and 23 Whereas, A. D. Guy was married to the former Margaret Holmes Guy, who 24 preceded him in death, and is survived by his sons: Alexander D. Guy Jr., Bundage H. Guy, and Douglas B. Guy; a stepson, Dennis Guthrie; five grandchildren: Alexander 25 Duke Guy III, Mallary W. Guy, Megan Jeaneal Guy, Bundage Jordan Guy, and Douglas 26 27 Taylor Guy; and three stepgrandchildren: Christopher Neil Adkins, Alexa Kay McMurtrey, and Jason Guthrie; Now, therefore, 28 29 Be it resolved by the Senate, the House of Representatives concurring: 30 Section 1. The General Assembly expresses its deep appreciation for the life and accomplishments of Alexander Duke "A. D."Guy and for the outstanding service he 31 32 rendered to the State of North Carolina, the County of Onslow, and the City of 33 Jacksonville. 34 Section 2.
