H 907. DEAF/HARD OF HEARING ADVISORY COUNCIL. Intro. 4/7/03. House committee substitute makes the following changes to 1st edition. Increases number of members on Council from 25 to 27 and amends title accordingly. nineteen members are to be appointed by the Governor upon recommendations of various groups set out in bill, 2 are to be appointed by the House, 2 by the Senate, and 4 by the Sec'y of Health and Human Services, also upon recommendations of groups set out in bill.
