**S 733. SMALL AND MEDIUM ANIMAL OPERATIONS PERMITS.** *TO STUDY THE USE OF GENERAL PERMITS FOR ANIMAL WASTE MANAGEMENT SYSTEMS FOR SMALL AND MEDIUM DAIRY, POULTRY, AND ANIMAL OPERATIONS AND RECOMMEND ANY ADDITIONAL PERMIT REQUIREMENTS THAT ARE NEEDED TO PROTECT WATER QUALITY.* As title indicates. Requires that Sec'y of Environment and Natural Resources, the Comm'r of Agriculture, and the Dean of the NCSU School of Agriculture, or their designees, perform study and submit final report no later than Aug. 1, 2007, to Environmental Review Comm'n.

**S 733. GEN. NONDISCHARGE PERMITS/ANIMAL OPERATIONS (NEW).** Intro. 4/3/03. Senate committee substitute makes the following changes to 1st edition. Makes act applicable to swine, cattle, and poultry operations (was, dairy, poultry, and animal operations). Amends sec. 1, requiring that Dep't of Environment and Natural Resources extend the expiration of general permits for swine, cattle, and poultry operations until Oct. 1, 2004 (was, to extend permits for small or medium dairy, poultry, and animal operations until May 1, 2008). Amends sec. 2 to require that DENR study general nondischarge permits (was, general permits), in consultation with Dept' of Agriculture and Consumer Services, the College of Agriculture and Life Sciences at NCSU, and industry and environmental groups. Further requires that DENR prepare and circulate draft revised general permits and make revisions in accordance with public comments, and submit study report to Environmental Review Comm'n by March 1, 2004 (was Aug. 1, 2007). Effective April 30, 2003.

**S 733. GEN. NONDISCHARGE PERMITS/ANIMAL OPERATIONS.** Intro. 4/3/03. Senate committee substitute makes the following changes to 2nd edition. Clarifies that requirements of sec. 1 (extension of general permits) apply notwithstanding 15A NCAC 2H.0225(e), and that extension of individual certificates of coverage shall be subject to cited federal and state regulations. Makes technical corrections.
