2	PROCLAMATIONS THAT BECOME EFFECTIVE IMMEDIATELY UPON
4	ISSUANCE AND TO MAKE OTHER TECHNICAL, CLARIFYING, AND
5	CONFORMING CHANGES.
6	The General Assembly of North Carolina enacts:
7	SECTION 1. G.S. 113-221 reads as rewritten:
8	"§ 113-221. Rules; proclamations; emergency Commission meetings.Rules.
9	(a) Chapter 150B of the General Statutes governs the adoption of rules under this
10	Article, other than proclamations issued under this Article. Article. Chapter 150B does
11	not apply to proclamations issued under this Article.
12	(b) Upon purchasing a license, each licensee shall be given a copy of the rules
13	concerning the activities authorized by the license.
14	(c) The Fisheries Director shall notify licensees of a new rule or change to a rule
15	by sending each licensee either a newsletter containing the text of the rule or change or
16	an updated codification of the rules of the Marine Fisheries Commission that contains
17	the new rule or change.
18	(d) Unless there are overriding policy considerations involved, any rule of the
19	Marine Fisheries Commission which will in the judgment of the Marine Fisheries
20	<u>Commission that will</u> result in severe curtailment of the usefulness or value of
21	equipment in which fishermen have any substantial investment should shall be given
22	such a future effective date so as to minimize undue potential economic loss to
23	fishermen. Whether or not any provision may cause potential economic loss rule will
24 25	result in severe curtailment of the usefulness or value of equipment in which fishermen
25 26	<u>have any substantial investment</u> and whether or not a future effective date should be set
26	is a matter within the complete sole discretion of the Marine Fisheries Commission. The

Marine Fisheries Commission need not set any future effective date more than two 1 2 years in advance of the passage adoption of any rule. 3 The Marine Fisheries Commission may delegate to the Fisheries Director the (e) 4 authority to issue proclamations suspending or implementing, in whole or in part, 5 particular rules of the Commission which may be affected by variable conditions. Such proclamations are to be issued by the Fisheries Director or by a person designated by 6 the Fisheries Director. All proclamations must state the hour and date upon which they 7 8 become effective and must be issued at least 48 hours in advance of the effective date 9 and time. In those situations in which the proclamation prohibits the taking of certain 10 fisheries resources for reasons of public health, the proclamation can be made effective immediately upon issuance. Notwithstanding any other provisions of this subsection, a 11 proclamation can be issued at least 12 hours in advance of the effective date and time to 12 13 reopen the taking of certain fisheries resources closed for reason of public health 14 through a prior proclamation made effective immediately upon issuance. Persons 15 violating any proclamation which is made effective immediately shall not be charged 16 with a criminal offense during the time between the issuance and 48 hours after such 17 issuance unless such person had actual notice of the issuance of such proclamation. 18 Fisheries resources taken or possessed by any person in violation of any proclamation may be seized regardless of whether such person had actual notice of the proclamation. 19 20 A permanent file of the text of all proclamations shall be maintained in the office of the 21 Fisheries Director. Certified copies of proclamations are entitled to judicial notice in 22 any civil or criminal proceeding. The Fisheries Director must make every reasonable effort to give actual notice of the 23 terms of any proclamation to the persons who may be affected thereby. Reasonable 24 25 effort includes press releases to communications media, posting of notices at docks and 26 other places where persons affected may gather, personal communication by inspectors and other agents of the Fisheries Director, and such other measures designed to reach 27 28 the persons who may be affected. It is a defense to an enforcement action for a violation of a proclamation that a licensee was prevented from receiving notice of the 29 proclamation due to a natural disaster or other act of God occasioned exclusively by 30 violence of nature without interference of any human agency and that could not have 31 32 been prevented or avoided by the exercise of due care or foresight.

Pursuant to the request of five or more members of the Marine Fisheries 33 (e1) Commission, its chairman may call an emergency meeting of the Commission to 34 35 review: (1) a proposed issuance or issuance of proclamations under the authority delegated to the Fisheries Director pursuant to (e) of this section, except those 36 proclamations issued for reasons of public health; or (2) the need to issue a 37 proclamation to allow the taking of certain fisheries resources in areas not opened 38 through proclamations issued by the Fisheries Director. At least 48 hours prior to any 39 such meeting, a public announcement of the meeting shall be issued that describes the 40 action requested by the members of the Commission; and the Department must make 41 every reasonable effort to give actual notice of the meeting to persons who may be 42 affected thereby. After its review is complete, the Marine Fisheries Commission, 43 consistent with its duty to protect, preserve, and enhance the commercial and sports 44

fisheries resources of the State, may (1) approve, cancel, or modify the proposed proclamation or issued proclamation under review; or (2) direct the Fisheries Director to issue a proclamation that allows the taking of certain fisheries resources.

4 The variable conditions that affect such resource management decisions require that 5 these emergency meetings and any resulting orders by the Commission be exempt from 6 the provisions of Article 2A of Chapter 150B. The decisions of the Marine Fisheries 7 Commission shall be the final decision of the State and shall not be set aside on judicial

8 review unless found to be arbitrary and capricious.

9 All persons who may be affected by them-rules adopted by the Marine (f) 10 Fisheries Commission and proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current rules of the Marine Fisheries Commission 11 12 and proclamations of the Fisheries Director. the current rules and proclamations. It is no defense in any criminal prosecution for the defendant to show that he the defendant in 13 14 fact received no notice of a particular rule or proclamation. In any prosecution for 15 violation of the provisions of anya rule or proclamation, or in which proof of matter contained in a rule or proclamation is involved, the Department is deemed to have 16 17 complied with publication procedures and the burden is on the defendant to show by the 18 greater weight of the evidence substantial failure of compliance by the Department with the required publication procedures. 19

- (g) Every court <u>must-shall</u> take judicial notice of any codification of rules issued by the Fisheries Director within two years preceding the date of the offense charged or transaction in issue. In the absence of any indication to the contrary, <u>such-the</u> codifications are to be deemed accurate and current statements of the text of the rules in question and it is incumbent upon any person asserting that a relevant portion of the codified text is inaccurate, or has been amended or deleted, to satisfy the court as to the text of the rules which-that is in fact properly applicable.

28 SECTION 2. Article 17 of Chapter 113 of the General Statutes is amended
29 by adding a new section to read:

"§ 113-221.1. Proclamations; emergency review.

The Marine Fisheries Commission may delegate to the Fisheries Director the 31 (a) 32 authority to issue proclamations suspending or implementing, in whole or in part, particular rules of the Commission that may be affected by variable conditions. These 33 proclamations shall be issued by the Fisheries Director or by a person designated by the 34 35 Fisheries Director. Except as provided in this subsection, all proclamations shall state the hour and date upon which they become effective and shall be issued at least 48 36 hours in advance of the effective date and time. A proclamation that prohibits the taking 37 38 of certain fisheries resources for reasons of public health or that governs a quota-managed fishery may be made effective immediately upon issuance. A 39 proclamation to reopen the taking of certain fisheries resources closed for reasons of 40 public health through a prior proclamation made effective immediately upon issuance 41 42 may be issued at least 12 hours in advance of the effective date and time of the reopening. A person violating any proclamation that is made effective immediately 43 upon issuance shall not be charged with a criminal offense during the time between the 44

issuance and 48 hours after the issuance unless the person had actual notice of the 1 2 issuance of the proclamation. Fisheries resources taken or possessed by any person in 3 violation of any proclamation may be seized regardless of whether the person had actual 4 notice of the proclamation. A permanent file of the text of all proclamations shall be 5 maintained in the office of the Fisheries Director. Certified copies of proclamations are 6 entitled to judicial notice in any civil or criminal proceeding. The Fisheries Director 7 shall make every reasonable effort to give actual notice of the terms of any proclamation 8 to persons who may be affected by the proclamation. Reasonable effort includes a press 9 release to communications media, posting of a notice at docks and other places where 10 persons affected may gather, personal communication by inspectors and other agents of the Fisheries Director, and other measures designed to reach the persons who may be 11 12 affected. It is a defense to an enforcement action for a violation of a proclamation that a person was prevented from receiving notice of the proclamation due to a natural disaster 13 14 or other act of God occasioned exclusively by violence of nature without interference of 15 any human agency and that could not have been prevented or avoided by the exercise of due care or foresight. 16 17 (b) Pursuant to the request of five or more members of the Marine Fisheries 18 Commission, the Chair of the Marine Fisheries Commission may call an emergency meeting of the Commission to review an issuance or proposed issuance of 19 20 proclamations under the authority delegated to the Fisheries Director pursuant to 21 subsection (a) of this section or to review the desirability of directing the Fisheries Director to issue a proclamation to allow the taking of certain fisheries resources. At 22 23 least 48 hours prior to any emergency meeting called pursuant to this subsection, a 24 public announcement of the meeting shall be issued that describes the action requested by the members of the Marine Fisheries Commission. The Department shall make every 25 reasonable effort to give actual notice of the meeting to persons who may be affected. 26 After its review is complete, the Marine Fisheries Commission, consistent with its duty 27 to protect, preserve, and enhance the commercial and sports fisheries resources of the 28 29 State, may approve, cancel, or modify the previously issued or proposed proclamation under review or may direct the Fisheries Director to issue a proclamation that allows the 30 taking of certain fisheries resources. An emergency meeting called pursuant to this 31 32 subsection and any resulting orders issued by the Marine Fisheries Commission are 33 exempt from the provisions of Article 2A of Chapter 150B of the General Statutes. The decisions of the Marine Fisheries Commission shall be the final decision of the State 34 35 and shall not be set aside on judicial review unless found to be arbitrary and capricious." SECTION 3. G.S. 143B-289.52(a)(8) reads as rewritten: 36 37 "§ 143B-289.52. Marine Fisheries Commission – powers and duties. 38 The Marine Fisheries Commission shall adopt rules to be followed in the (a) 39 management, protection, preservation, and enhancement of the marine and estuarine resources within its jurisdiction, as described in G.S. 113-132, including commercial 40 and sports fisheries resources. The Marine Fisheries Commission shall have the power 41 42 and duty:
