1	A BILL TO BE ENTITLED
2	AN ACT TO PROVIDE CANDIDATES FOR CERTAIN COUNCIL OF STATE
3	OFFICES WITH THE OPTION OF FINANCING THEIR CAMPAIGNS FROM A
4	PUBLICLY SUPPORTED FUND, PROVIDED THAT THEY GAIN
5	AUTHORIZATION TO DO SO FROM REGISTERED VOTERS AND THAT
6	THEY ABIDE BY STRICT FUND-RAISING AND SPENDING LIMITS.
7	The General Assembly of North Carolina enacts:
8	SECTION 1. Chapter 163 of the General Statutes is amended by adding a
9	new Article to read:
10	" <u>Article 22E.</u>
11	"The Voter-Owned Elections Act.
12	" <u>§ 163-278.75. Purpose and establishment of Voter-Owned Elections Act.</u>
13	The purpose of this Article is to ensure the vitality and fairness of democratic
14	elections in North Carolina, to the end that any eligible citizen of this State can
15	realistically choose to seek and run for public office. It is also the purpose of this Article
16	to protect the constitutional rights of voters and candidates from the detrimental effects
17	of increasingly large amounts of money being raised and spent in North Carolina to
18	influence the outcome of elections. It is essential to the public interest that the potential
19	for corruption or the appearance of corruption is minimized and that the equal and
20	meaningful participation of all citizens in the democratic process is ensured.
21	Accordingly, this Article establishes the North Carolina Voter-Owned Elections Fund as
22	an alternative source of campaign financing for candidates who obtain a sufficient
23	number of qualifying contributions from registered voters and who voluntarily accept
24	strict fund-raising and spending limits. This Article is available to candidates for the
25	Council of State offices of Secretary of State, Auditor, Treasurer, Superintendent of
26	Public Instruction, Attorney General, Commissioner of Agriculture, Commissioner of

7	(b) Demonstration of Support of Candidacy. – In order to be certified,
8	participating candidates must obtain qualifying contributions from at least 2,000
9	registered voters in this State. No more than a third of a candidate's qualifying
10	contributions submitted to the Board for purposes of certification shall come from
11	registered voters who are residents of the same congressional district. No payment, gift,
12	or anything of value shall be given in exchange for a qualifying contribution.
13	(c) <u>Certification of Candidates. – Upon receipt of a submittal of the record of</u>
14	qualifying contributions by a participating candidate, the Board shall determine whether
15	or not the candidate has:
16	(1) Filed a completed declaration of intent to participate in this Article.
17	(2) Submitted copies of the appropriate number of forms described in G.S.
18	163-278.76(15) signed by contributors who are registered voters,
19	which the Board shall verify through a random sample or other means
20	it adopts.
21	(3) Qualified as a candidate for the office.
22	(4) Otherwise met the requirements for participation in this Article.
23	The Board shall certify candidates complying with the requirements of this section
24	as soon as possible and no later than five business days after receipt of a satisfactory
25	record of qualifying contributions.
26	(d) <u>Final Report for Qualifying Contributions. – No later than five business days</u>
27	after the end of the qualifying period, all participating candidates shall submit a report
28	to the Board of all previously unreported qualifying contributions, together with copies
29	of the contribution forms described in G.S. 163-278.76(15), in accordance with
30	procedures developed by the Board. Within seven business days after submittal of the

(e) Restrictions on Contributions and Expenditures for Participating and Certifice Candidates. – The following restrictions shall apply to contributions and expenditures with respect to participating and certified candidates: (1) Beginning January 1 of the year before the election and before filing declaration of intent, a candidate shall limit campaign-relate expenditures to ten thousand dollars (\$10,000) and shall not accept more than ten thousand dollars (\$10,000) from sources and in amoun permitted by Article 22A of this Chapter. A candidate who exceed either of these limits shall be ineligible to file a declaration of intent of receive funds from the Fund.

20	<u>,</u>	falls outside that permitted by this subsection shall be returned to the
21		donor as soon as practicable. Contributions intentionally made,
22		solicited, or accepted in violation of this Article are subject to civil
23		penalties as specified in G.S. 163-278.84. The funds involved shall be
23 24		forfeited to the Civil Penalty and Forfeiture Fund.
25	(7)	A candidate shall return to the Fund any amount distributed for an

4	(b) Amount of Fund Distribution. – By April 1, 2005, and no less frequently than
5	every four years thereafter, the Board shall determine the base level of funds to be
6	distributed to certified candidates. No funds are distributed for uncontested elections.

8	by any qualifying contributions raised above the maximum amount of qualifying

21	(c) <u>Method of Fund Distribution. – The Board, in consultation with the State</u>
22	Treasurer and the State Controller, shall develop a rapid, reliable method of conveying
23 24	funds to certified candidates. In all cases, the Board shall distribute funds to certified
25	candidates in a manner that is expeditious, ensures accountability, and safeguards the
26	integrity of the Fund. If the money in the Fund is insufficient to fully fund all certified
20 27	candidates, then the available money shall be distributed proportionally, according to
28	each candidate's eligible funding.
29	"§ 163-278.80. Reporting requirements.
30	(a) <u>Reporting by Noncertified Candidates and Independent Expenditure Entities.</u>
31	- Any noncertified candidate with a certified opponent shall report total income,
32	expenses, and obligations to the Board by facsimile machine or electronically within 24
33	hours after the total amount of campaign-related expenditures or obligations made, or
34	funds raised or borrowed, exceeds eighty percent (80%) of the trigger for rescue funds
35	as defined in G.S. 163-278.76(17). Any entity making independent expenditures in
36	excess of three thousand dollars (\$3,000) in support of or opposition to a certified
37	candidate, or in support of a candidate opposing a certified candidate, shall report the
38	total funds received, spent, or obligated for those expenditures to the Board by facsimile
39	machine or electronically within 24 hours after the total amount of expenditures or
40	obligations made, or funds raised or borrowed, for the purpose of making the
41	independent expenditures, exceeds fifty percent (50%) of the trigger for rescue funds.
42	After this 24-hour filing, the noncertified candidate or independent expenditure entity
43	shall comply with an expedited reporting schedule by filing additional reports after
44	receiving each additional amount in excess of one thousand dollars (\$1,000) or after

2	dollars (\$1,000). The schedule and forms for reports required by this subsection shall be
3	made according to procedures developed by the Board.
4	(b) <u>Reporting by Participating and Certified Candidates. – Notwithstanding other</u>
5	provisions of law, participating and certified candidates shall report any money
6	received, all campaign expenditures, obligations, and related activities to the Board
7	according to procedures developed by the Board. Upon the filing of a final report for
8	any losing primary election, special election, or general election, each candidate who
9	has revenues from the Fund remaining unspent shall return those revenues to the Board.
10	In developing these procedures, the Board shall utilize existing campaign reporting
11	procedures wherever practicable.
12	(c) <u>Timely Access to Reports. – The Board shall ensure prompt public access to</u>
13	the reports received in accordance with this Article. The Board may utilize electronic
14	means of reporting and storing information.
15	" <u>§ 163-278.81. Rescue funds.</u>
16	(a) When Rescue Funds Become Available. – When any report or group of
17	reports shows that 'funds in opposition to a certified candidate or in support of an
18	opponent to that candidate' as described in this section, exceed the trigger for rescue
19	funds as defined in G.S. 163-278.76(17), the Board shall issue immediately to that
20	certified candidate an additional amount equal to the reported excess within the limits
21	set forth in this section. 'Funds in opposition to a certified candidate or in support of an
22	opponent to that candidate' shall be equal to the sum of the following:
23	(1) Campaign expenditures or obligations made, or funds raised or
24	borrowed, whichever is greater, reported by any one uncertified
25	opponent of a certified candidate. Where a certified candidate has
26	more than one uncertified opponent, the measure shall be taken from
27	the uncertified candidate showing the highest relevant dollar amount.
28	(2) The sum of all expenditures reported in accordance with G.S.
29	163-278.80(a) of entities making independent expenditures in
30	opposition to the certified candidate or in support of any opponent of
31	that certified candidate.
32	(b) Limit on Rescue Funds in Contested Primary. – Total rescue funds to a
33	certified candidate in a contested primary shall be limited to an amount equal to two
34	times the maximum qualifying contributions.
35	(c) Limit on Rescue Funds in Contested General Election. – Total rescue funds to
36	a certified candidate in a contested general election shall be limited to an amount equal
37	to two times the amount described in G.S. 163-278.79(b)(2).
38	" <u>§ 163-278.82. Unaffiliated and new-party candidates.</u>
39	Unaffiliated candidates certified pursuant to G.S. 163-122 and new-party candidates
40	certified pursuant to G.S. 163-98 shall be eligible for revenues from the Fund in the
41	same amounts and at the same time as specified in G.S. 163-278.79. For unaffiliated
42	candidates and new-party candidates not certified to appear on the ballot by noon on the
43	first Monday in February, the deadline for seeking certification to receive revenue from
44	the Fund is noon on the first business day of July of the election year.

1	"§ 163-278.83. Enforcement by the Board; civil penalty.
2	The Board, with the advice of the Advisory Council established under
3	G.S.163.278.68(b), shall administer the provisions of this Article in the same manner as
4	described in Article 22D. In addition to any other penalties that may be applicable, any
5	individual, political committee, or other entity that violates any provision of this Article
6	is subject to a civil penalty in the same manner as described in Article 22D."
7	SECTION 2. G.S. 163-278.13 is amended by adding a new subsection to
8	read:
9	"(e3) In order to make meaningful the provisions of the North Carolina Voter-
10	Owned Elections Act, as set forth in Article 22E of this Chapter, no candidate for any
11	office that is in that current election subject to the provisions of Article 22E shall accept
12	a contribution during the period beginning 21 days before the day of the general election
13	and ending the day after the general election. No contributor shall make a contribution
14	to a candidate for any office that is in that current election subject to the provisions of
15	Article 22E during the period beginning 21 days before the general election and ending
16	the day after the general election. The prohibitions in this subsection shall also apply to
17	a political committee the principal purpose of which is to support a candidate for those
18	offices. Nothing in this subsection shall prohibit a candidate from making a contribution
19	or loan secured entirely by that candidate's assets to that candidate's own campaign or to
20	a political committee the principal purpose of which is to support that candidate's
21	campaign. This subsection applies with respect to a candidate only if both of the
22	following statements are true regarding that candidate:
23	(1) That candidate is opposed in the general election by a certified
24	candidate as defined in Article 22E of this Chapter.
25	(2) That certified candidate has not received the maximum rescue funds
26	available under G.S. 163-278.81(c).
27	The recipient of a contribution that apparently violates this subsection has three days
28	to return the contribution or file a detailed statement with the State Board of Elections
29	explaining why the contribution does not violate this subsection."
30	SECTION 3. The provisions of this act are severable. If any provision of
31	this act is held invalid by a court of competent jurisdiction, the invalidity does not affect
32	other provisions of the act that can be given effect without the invalid provision.
33	SECTION 4. There is appropriated from the General Fund to the State
34	Board of Elections the sum of twenty-five thousand dollars (\$25,000) for the 2003-2004
35	fiscal year and the sum of fifty thousand dollars (\$50,000) for the 2004-2005 fiscal year
36	for the administration of this act.
37	SECTION 5. This act applies to elections for Secretary of State, Auditor,
38	Treasurer, Superintendent of Public Instruction, Attorney General, Commissioner of
39	Agriculture, Commissioner of Labor, and Commissioner of Insurance in 2008 and
40	thereafter. Section 4 of this act becomes effective January 1, 2004. The remainder of
41	this act is effective when it becomes law.
