1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A
3 "HOMES4NC" SPECIAL REGISTRATION PLATE.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

6 "(b) Types. – The Division shall issue the following types of special registration
7 plates:

8 ...

9 (18a) HOMES4NC Plate. – Issuable to the registered owner of a motor
10 vehicle in accordance with G.S. 20-81.12. The plate shall bear
11 'HOMES4NC', the logo of the North Carolina Association of Realtors
12 Housing Opportunity Foundation, and shall be developed in
13 conjunction with that organization. The Division may not issue the
14 plate authorized by this subdivision unless it receives at least 300
15 applications for the plate."

16 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

17 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one
18 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
19 veteran, and an ex-prisoner of war. All other special registration plates, including
20 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of
21 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or
22 G.S. 20-88 plus an additional fee in the following amount:

41 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

42 "(b) Distribution of Fees. – The Special Registration Plate Account and the
43 Collegiate and Cultural Attraction Plate Account are established within the Highway
44 Fund. The Division must credit the additional fee imposed for the special registration

1 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
 2 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
 3 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
 4 Trust Fund, which is established under G.S. 113-44.15, as follows:

2 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:

3 "(b31) HOMES4NC. – The Division must receive 300 or more applications for the
4 HOMES4NC plate before the plate may be developed. The Division shall transfer
5 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
6 from the sale of the HOMES4NC plates to the NCAR Housing Opportunity Foundation
7 to promote safe, decent, and affordable housing for all in North Carolina."

8 **SECTION 5.** This act is effective when it becomes law.
