Distribution of Fees. - The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the

<b>SECTION 4.</b> G.S. 20-81.12 is amended by adding a new subsection to read:
"(b31) HOMES4NC. – The Division must receive 300 or more applications for the
HOMES4NC plate before the plate may be developed. The Division shall transfer
quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
from the sale of the HOMES4NC plates to the NCAR Housing Opportunity Foundation
to promote safe, decent, and affordable housing for all in North Carolina."
SECTION 5 This act is effective when it becomes law
