## A BILL TO BE ENTITLED

## AN ACT TO NAME THE WESTERN JUSTICE ACADEMY IN HONOR OF

 REPRESENTATIVE LARRY T. JUSTUS.The General Assembly of North Carolina enacts:
SECTION 1. The Western Justice Academy located at Edneyville in Henderson County is part of the North Carolina Department of Justice and provides training programs for criminal justice personnel and technical assistance to criminal justice agencies to aid them in the discharge of their responsibilities. The Western Justice Academy is hereby designated the Larry T. Justus Western Justice Academy in recognition of Representative Larry T. Justus' dedicated leadership in the North Carolina General Assembly on justice and public safety issues and his commitment to the safety and well-being of the citizens of this State.

SECTION 2. This act is effective when it becomes law.
