5	The General Assembly of North Carolina enacts:
6	SECTION 1. There is appropriated from the General Fund to the
7	Department of Health and Human Services the sum of two million dollars (\$2,000,000)
8	for the 2003-2004 fiscal year and the sum of two million dollars (\$2,000,000) for the
9	2004-2005 fiscal year. These funds shall be allocated to the Institute of Public Health at
10	the University of North Carolina at Chapel Hill for a public health improvement
11	demonstration project in enterprise tier one counties and other counties affiliated with
12	tier one counties through district health departments in northeastern North Carolina. For
13	purposes of this section, "enterprise tier" has the same meaning as under G.S.
14	105-129.2. The regional demonstration project will incorporate collaboration and
15	tasking across county lines. The funds shall be used as follows:
16	(1) For the demonstration of health assessment functions, including the
17	strengthening of epidemiological investigation capacity; active
18	monitoring and surveillance of health conditions, diseases, and risk
19	factors; involving the community in community health assessments;
20	public awareness of health conditions and reporting of health issues to
21	the general community and to risk groups; institutionalizing the
22	capacity to monitor closure of disparity gaps; and monitoring,
23	measuring, and evaluating health outcomes.
24	(2) For the demonstration of public health policy development, including
25	the retraining of the public health workforce, mobilizing community
26	and coalition infrastructures, broadening the public health agenda
27	through activation of the policy development role of local boards of

- health, and the development of policies and readiness for emerging
  public health threats.
- 3 (3) For the demonstration of assurance functions, including the 4 development of key accountability and performance measures, piloting 5 a local health department accreditation system, the identification of 6 major health system gaps, the translation of public health research into 7 practice, and the development of model guidelines, policies, and 8 procedures.
- 9 (4) For the development of a proposed State funding system for core 10 public health functions and essential public health services with 11 emphasis on county wealth, county need, and incentive to collaborate 12 and share resources on a regional level.
- 13 (5) For defining and measuring the public health infrastructure as
  14 demonstrated by research at the federal level through the Centers for
  15 Disease Control and Prevention.

**SECTION 2.** There is appropriated from the General Fund to the Reserve for State Aid to Counties the sum of thirteen million dollars (\$13,000,000) for the 2003-2004 fiscal year and the sum of thirteen million dollars (\$13,000,000) for the 2004-2005 fiscal year. Of these funds, the sum of one hundred thirty thousand dollars (\$130,000) shall be allocated in each fiscal year to each of the State's 100 counties as noncategorical funding. Each county may use funds received under this section as follows:

- To enhance core and essential local public health functions including assessment.
- (2) For policy development, assurance of access to needed health services, and reduction of disparities and barriers to care.
- (3) To partner with other local entities to promote development and enhance community health.
- 29 **SECTION 3.** This act becomes effective July 1, 2003.
