1	A BILL TO BE ENTITLED
2	AN ACT ESTABLISHING THE TRADE JOBS FOR SUCCESS INITIATIVE TO
3	STIMULATE JOB GROWTH AND HIRING IN NORTH CAROLINA AND
4	APPROPRIATING FUNDS FOR THAT PURPOSE.
5	The General Assembly of North Carolina enacts:
6	SECTION 1.(a) There is appropriated from the General Fund to the
7	Department of Commerce the sum of one million five hundred thousand dollars
8	(\$1,500,000) for the 2004-2005 fiscal year for the Trade Jobs for Success initiative
9	established by this act.
10	SECTION 1.(b) There is appropriated from the General Fund to the
11	Community Colleges System Office the sum of seven hundred fifty thousand dollars
12	(\$750,000) for the 2004-2005 fiscal year to help fund participation of local community
13	colleges in the Trade Jobs for Success initiative.
14	SECTION 1.(c) Prior to the granting of a waiver by the U.S. Department of
15	Labor, the funds appropriated in subsection (a) of this section shall be used to start-up
16	the initiative. It is the intent of the General Assembly to appropriate additional State
17	funds for the initiative in the 2005-2006 fiscal year as may be necessary to supplement
18	federal funds and to further stimulate job growth and hiring in the State.
19	SECTION 2. The Department of Commerce, in cooperation with the
20	Employment Security Commission and the North Carolina Community College System
21	shall begin implementation of the Trade Jobs for Success initiative in the counties
22	hardest hit by trade impacted job losses and the resulting decline of traditional North
23	Carolina industries including the textile, clothing, and furniture industries and other
24	manufacturing operations. Counties having an unemployment rate of eight percent (8%)
25	or more shall receive priority consideration.
26	SECTION 3. The Employment Security Commission shall take all actions
27	practicable to obtain from the U.S. Department of Labor as quickly as possible a waiver

1	under the Trade Adjustment Act to allow the Trade Jobs for Success initiative to (i)
2	serve persons regardless of their age, (ii) use unemployment funds to provide direct
3	monetary incentives to participating employers and direct income to eligible workers in
4	the retraining program, and (iii) use funds for in-State relocation assistance. Waivers
5	shall be sought for other program components, as appropriate.
6	SECTION 4. The Department of Commerce shall seek, and may receive,
7	private grants and federal funds for the Trade Jobs for Success initiative.
8	SECTION 5. Article 10 of Chapter 143B of the General Statutes is amended
9	by adding a new Part to read:
10	"Part 3C. Trade Jobs For Success.
11	" <u>§ 143B-438.15. Legislative findings and purpose.</u>
12	(a) The General Assembly finds that State, national, and global economic
13	conditions and the passage of international trade agreements have impacted the State
14	workforce adversely and resulted in significant losses in the availability of jobs in
15	manufacturing and the State's other traditional industries. Further, the General
16	Assembly finds that business and plant closings, the weakened State economy, and
17	lengthening periods of unemployment have taken a toll on communities across the
18	State. It is prudent to address the loss of jobs by establishing a statewide initiative to
19	create more jobs for our citizens.
20	(b) It is the policy of this State to stimulate job growth and hiring by investing in
21	the effective retraining of trade-affected displaced workers while partnering with private
22	business to help those citizens learn new skills for new jobs through on-the-job training
23	and educational assistance.
24	(c) The purpose of this Part is to establish the Trade Jobs for Success initiative to
25	stimulate job growth and hiring in the State and to assist displaced workers affected by
26	trade-impact business closings. The aim of the Trade Jobs for Success initiative shall be
27	to partner with private business to move displaced workers into new jobs while allowing
28	for a dignified transition from unemployment back to employment.
29	"§ 143B-438.16. Trade Jobs for Success initiative established; funds; program
30	components and guidelines.
31	(a) There is established within the Department of Commerce the Trade Jobs for
32	Success (TJS) initiative. The Department of Commerce shall lead the TJS initiative in
33	cooperation with the Employment Security Commission and the Community Colleges
34	System Office.
35	(b) There is created in the Department of Commerce a special, nonreverting fund
36	called the Trade Jobs for Success Fund (Fund). The Fund shall be used to implement the
37	TJS initiative. The Department of Commerce shall develop guidelines for
38	administration of the TJS initiative and the Fund. An advisory council shall assist the
39	Secretary of Commerce in the administration of the Fund. The members of the advisory
40	council shall include:
41	(1) <u>The Chairman of the Employment Security Commission or that</u>
42	<u>officer's designee.</u>
43	(2) <u>The President of the Community Colleges System or that officer's</u>

(c) At a	minimum, the Trade Jobs for Success initiative shall include the
	ammatic components:
(1)	Displaced workers participating in the TJS initiative shall receive (i)
<u>(1)</u>	on-the-job training to learn new job skills and (ii) educational
	assistance or remedial education specifically designed to help
	displaced workers qualify for new jobs.
(2)	Displaced workers participating in the TJS initiative shall not lose their

1	The Department of Commerce, in conjunction with the Employment Security
2	Commission and the Community Colleges System Office, shall publish a quarterly
3	report on the Trade Jobs for Success initiative. The report shall provide information on
4	the commitment, disbursement, and use of funds and the status of any grant proposals or
5	waivers requested on behalf of the Trade Jobs for Success initiative. The report shall
6	also include legislative proposals and recommendations regarding statutory changes
7	needed to maximize the effectiveness and flexibility of the TJS initiative. Copies of the
8	report shall be provided to the Joint Legislative Commission on Governmental
9	Operations, to the chairs of the Senate and House of Representatives Appropriations
10	Committee, and to the Fiscal Research Division of the General Assembly."
11	SECTION 6. This act becomes effective July 1, 2004.
