A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A 4-H SPECIAL REGISTRATION PLATE.

Whereas, 4-H is an outstanding youth development program that serves almost 200,000 youth in North Carolina and over 7,000,000 youth nationally each year; and

Whereas, 4-H promotes values, integrity, leadership, and community involvement, serving as a positive influence on the youth of our society; and

Whereas, 4-H has a long and rich history in North Carolina and will celebrate its State centennial in 2009; Now, therefore,

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

15 .

(15b) 4-H. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear '4-H' and the 4-H four-leaf clover logo. The Division may not issue the plate authorized by this subdivision unless it receives at least 300 applications for the plate."

SECTION 2. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

SECTION 3. G.S. 20-79.7(b) reads as rewritten:

Distribution of Fees. - The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

SECTION 4. G.S. 20-81.12 is amended by adding a new subsection to read: "(b31) 4-H. – The Division must receive 300 or more applications for the 4-H plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of the 4-H plates to The 4-h Club foundation of North Carolina, Inc., to support three initiatives: county 4-H programs in all 100 counties and on the Qualla boundary, the NC State 4-H program, and for repair and renovations at the five 4-H camps and conference centers in this State."

SECTION 5. This act is effective when it becomes law.
