4	Whereas, State laws pertaining to guardianship and powers of attorney are
5	important for the protection of citizens who are unable to make personal decisions due
6	to mental or physical impairment or incapacity; and
7	Whereas, by virtue of an increasing elderly population, the number and
8	circumstance of persons who currently need or may need in the future alternate decision
9	makers to act in their best interest is also increasing; and
10	Whereas, the State's guardianship laws have not been thoroughly reviewed in
11	more than 12 years to determine if changes in content or policy are needed to strengthen
12	the efficiency and effectiveness of these laws; Now, therefore,
13	The General Assembly of North Carolina enacts:
14	SECTION 1.(a) There is created the Legislative Study Commission on State
15	Guardianship Laws. The purpose of the Commission is to review State law pertaining to
16	guardianship and its relationship to other pertinent State laws such as the health care
17	power of attorney, the right to a natural death, and durable power of attorney.
18	SECTION 1.(b) The Commission shall consist of 14 members, seven
19	members appointed by the Speaker of the House of Representatives, at least four of
20	whom shall be members of the House of Representatives, and seven members appointed
21	by the President Pro Tempore of the Senate, at least four of whom shall be members of
22	the Senate. The public members appointed by the Speaker and the President Pro
23	Tempore shall be such persons as have experience with the State guardianship laws,
24	including court administrators, attorneys, judges, public or private guardians, or
25	representatives of the interests of elderly and disabled persons. The Speaker shall
26	designate one Representative as cochair, and the President Pro Tempore shall designate
27	one Senator as cochair. Vacancies on the Commission shall be filled by the same

GENERAL ASSEMBLY OF NORTH CAROLINA

1	SECTION 2. The Legislative Study Commission on State Guardianship
2	Laws may make an interim report to the 2003 General Assembly not later than the
3	convening of the 2003 General Assembly, 2004 Regular Session, and shall make its
4	final report to the 2005 General Assembly upon its convening.
5	SECTION 3. All State departments and agencies and local governments and
6	their subdivisions shall furnish the Commission with any information in their possession
7	or available to them.
8	SECTION 4. There is appropriated from the General Fund to the General
9	Assembly the sum of thirty thousand dollars (\$30,000) for the 2003-2004 fiscal year and
10	the sum of thirty thousand dollars (\$30,000) for the 2004-2005 fiscal year to carry out
11	the purposes of this act.
