A BILL TO BE ENTITLED 1 2 AN ACT TO MAKE STATEWIDE AN ACT CURRENTLY APPLICABLE TO 3 CHARLOTTE AND RALEIGH THAT DEEMS THE CREATION OF A 4 SELF-FUNDED RISK PROGRAM AS THE PURCHASE OF INSURANCE FOR 5 THE PURPOSE OF WAIVING GOVERNMENTAL IMMUNITY. 6 The General Assembly of North Carolina enacts: **SECTION 1.** G.S. 160A-485(a) reads as rewritten: 7 8 "(a) Any city is authorized to waive its immunity from civil liability in tort by the 9 act of purchasing liability insurance. Participation in a local government risk pool pursuant to Article 23 of General Statute Chapter 58 shall be deemed to be the purchase 10 of insurance for the purposes of this section. Immunity shall be waived only to the 11 extent that the city is indemnified by the insurance contract from tort liability. No 12 formal action other than the purchase of liability insurance shall be required to waive 13 14 tort immunity, and no city shall be deemed to have waived its tort immunity by any action other than the purchase of liability insurance. If a city uses a funded reserve 15 instead of purchasing insurance against liability for wrongful death, negligence, or 16 intentional damage to personal property, or absolute liability for damage to person or 17 property caused by an act or omission of the city or any of its officers, agents, or 18 employees acting within the scope of their authority and the course of their 19 employment, the city council may adopt a resolution that deems the creation of a funded 20 reserve to be the same as the purchase of insurance under this section. Adoption of such 21 22 a resolution waives the city's governmental immunity only to the extent specified in the council's resolution, but in no event greater than funds available in the funded reserve 23 for the payment of claims." 24 25 SECTION 2. Section 2 of S.L. 1998-200, as amended by S.L. 2002-79, is repealed, but any resolution adopted under that section and still effective on the 26
