#### A BILL TO BE ENTITLED

2 AN ACT TO PROHIBIT STUDENTS FROM DROPPING OUT OF SCHOOL3 BEFORE THE AGE OF SEVENTEEN.

4 The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 115C-378 reads as rewritten:

#### 6 "§ 115C-378. Children required to attend.

7 Every parent, guardian or other person in this State having charge or control of a 8 child between the ages of seven and 16-17 years shall cause such child to attend school 9 continuously for a period equal to the time which the public school to which the child is 10 assigned shall be in session. Every parent, guardian, or other person in this State having charge or control of a child under age seven who is enrolled in a public school in grades 11 kindergarten through two shall also cause such child to attend school continuously for a 12 13 period equal to the time which the public school to which the child is assigned shall be in session unless the child has withdrawn from school. No person shall encourage, 14 15 entice or counsel any such child to be unlawfully absent from school. The parent, 16 guardian, or custodian of a child shall notify the school of the reason for each known absence of the child, in accordance with local school policy. 17

The principal, superintendent, or teacher who is in charge of such school shall have the right to excuse a child temporarily from attendance on account of sickness or other unavoidable cause which does not constitute unlawful absence as defined by the State Board of Education. The term "school" as used herein is defined to embrace all public schools and such nonpublic schools as have teachers and curricula that are approved by the State Board of Education.

All nonpublic schools receiving and instructing children of a compulsory school age shall be required to keep such records of attendance and render such reports of the attendance of such children and maintain such minimum curriculum standards as are required of public schools; and attendance upon such schools, if the school refuses or neglects to keep such records or to render such reports, shall not be accepted in lieu of

attendance upon the public school of the district to which the child shall be assigned: 1

2 Provided, that instruction in a nonpublic school shall not be regarded as meeting the 3 requirements of the law unless the courses of instruction run concurrently with the term 4 of the public school in the district and extend for at least as long a term.

5 The principal or his designee shall notify the parent, guardian, or custodian of his 6 child's excessive absences after the child has accumulated three unexcused absences in a school year. After not more than six unexcused absences, the principal shall notify the 7 8 parent, guardian, or custodian by mail that he may be in violation of the Compulsory 9 Attendance Law and may be prosecuted if the absences cannot be justified under the 10 established attendance policies of the State and local boards of education. Once the parents are notified, the school attendance counselor shall work with the child and his 11 12 family to analyze the causes of the absences and determine steps, including adjustment 13 of the school program or obtaining supplemental services, to eliminate the problem. The 14 attendance counselor may request that a law-enforcement officer accompany him if he 15 believes that a home visit is necessary.

16 After 10 accumulated unexcused absences in a school year the principal shall review 17 any report or investigation prepared under G.S. 115C-381 and shall confer with the 18 student and his parent, guardian, or custodian if possible to determine whether the 19 parent, guardian, or custodian has received notification pursuant to this section and 20 made a good faith effort to comply with the law. If the principal determines that parent, 21 guardian, or custodian has not, he shall notify the district attorney. If he determines that 22 parent, guardian, or custodian has, he may file a complaint with the juvenile court 23 counselor pursuant to Chapter 7B of the General Statutes that the child is habitually 24 absent from school without a valid excuse. Evidence that shows that the parents, guardian, or custodian were notified and that the child has accumulated 10 absences 25 which cannot be justified under the established attendance policies of the local board 26 27 shall establish a prima facie case that the child's parent, guardian, or custodian is responsible for the absences." 28

**SECTION 2**. G.S. 116-235(b)(2) reads as rewritten:

- 30 School Attendance. - Every parent, guardian, or other person in this "(2) State having charge or control of a child who is enrolled in the School 31 and who is less than 16-17 years of age shall cause such child to 32 attend school continuously for a period equal to the time which the 33 34 School shall be in session. No person shall encourage, entice, or 35 counsel any child to be unlawfully absent from the School. Any person who aids or abets a student's unlawful absence from the School shall, 36 upon conviction, be guilty of a Class 3 misdemeanor. The Director of 37 the School shall be responsible for implementing such additional 38 39 policies concerning compulsory attendance as shall be adopted by the Board of Trustees, including regulations concerning lawful and 40 unlawful absences, permissible excuses for temporary absences, 41 42 maintenance of attendance records, and attendance counseling." 43
  - **SECTION 3.** G.S. 7B-1501(27) reads as rewritten:
