A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE DRIVERS LICENSES VALID FOR UP TO EIGHT YEARS AND TO ISSUE REGISTRATION PLATES VALID FOR UP TO TWO YEARS AS RECOMMENDED BY THE GOVERNOR'S EFFICIENCY COMMISSION.

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 20-7(f) reads as rewritten:

"(f) Expiration and Temporary License. – The first drivers license the Division issues to a person expires on the person's fourth or subsequent birthday that occurs after the license is issued and on which the individual's age is evenly divisible by five, unless this subsection sets a different expiration date. A first drivers license may be issued for a shorter duration if the Division determines that a license of shorter duration should be issued when the applicant holds a visa of limited duration issued by the United States Department of State. The first drivers license the Division issues to a person who is at least 17 years old but is less than 18 years old expires on the person's twentieth birthday. The first drivers license the Division issues to a person who is at least 62 years old expires on the person's birthday in the fifth year after the license is issued, whether or not the person's age on that birthday is evenly divisible by five.

A drivers license that was issued by the Division and is renewed by the Division expires five eight years after the expiration date of the license that is renewed unless the Division determines that a license of shorter duration should be issued when the applicant holds a visa of limited duration from the United States Department of State. A person may apply to the Division to renew a license during the 180-day period before the license expires. The Division may not accept an application for renewal made before the 180-day period begins.

The Division may renew by mail a drivers license issued by the Division to a person who meets any of the following descriptions:

- (1) Is serving on active duty in the armed forces of the United States and is stationed outside this State.
  - (2) Is a resident of this State and has been residing outside the State for at least 30 continuous days.

When renewing a license by mail, the Division may waive the examination that would otherwise be required for the renewal and may impose any conditions it finds advisable. A license renewed by mail is a temporary license that expires 60 days after the person to whom it is issued returns to this State."

## **SECTION 2.** G.S. 20-66(a) reads as rewritten:

"(a) Annual Biennial Renewal. – The registration of a vehicle must shall be renewed annually.every two years. To renew the registration of a vehicle, the owner of the vehicle must shall file an application with the Division and pay the required registration fee. The Division may receive and grant an application for renewal of registration at any time before the registration expires."

## **SECTION 3.** G.S. 20-87 reads as rewritten:

## "§ 20-87. Passenger vehicle registration fees.

These shall be paid to the Division annually, as of the first day of January, for the registration and licensing of passenger vehicles, fees according to the following classifications and schedules:schedules, which are based on the applicable annual rate:

- (1) For-Hire Passenger Vehicles. The fee for a passenger vehicle that is operated for compensation and has a capacity of 15 passengers or less is seventy-eight dollars (\$78.00). The fee for a passenger vehicle that is operated for compensation and has a capacity of more than 15 passengers is one dollar and forty cents (\$1.40) per hundred pounds of empty weight of the vehicle.
- (2) U-Drive-It Vehicles. U-drive-it vehicles shall pay the following tax:

- (4) Limousine Vehicles. For-hire passenger vehicles on call or demand which do not solicit passengers indiscriminately for hire between points along streets or highways, shall be taxed at the same rate as for-hire passenger vehicles under G.S. 20-87(1) but shall be issued

appropriate registration plates to distinguish such vehicles from 1 2 taxicabs. 3 (5) Private Passenger Vehicles. - There shall be paid to the Division annually, as of the first day of January, for the registration and 4 5 licensing of private passenger vehicles, fees according to the following 6 classifications and schedules: 7 Private passenger vehicles of not more than fifteen passengers ......\$20.00 8 9 10 Provided, that a fee of only one dollar (\$1.00) shall be charged for any vehicle given by the federal government to any veteran on account of 11 12 any disability suffered during war so long as such vehicle is owned by 13 the original donee or other veteran entitled to receive such gift under 14 Title 38, section 252, United States Code Annotated. 15 (6) Private Motorcycles. – The base fee on private passenger motorcycles 16 shall be nine dollars (\$9.00); except that when a motorcycle is 17 equipped with an additional form of device designed to transport 18 persons or property, the base fee shall be sixteen dollars (\$16.00). An 19 additional fee of three dollars (\$3.00) is imposed on each private motorcycle registered under this subdivision in addition to the base 20 21 fee. The revenue from the additional fee, in addition to any other funds 22 appropriated for this purpose, shall be used to fund the Motorcycle Safety Instruction Program created in G.S. 115D-72. 23 Dealer License Plates. – The fee for a dealer license plate is the regular 24 (7) 25 fee for each of the first five plates issued to the same dealer and is one-half the regular fee for each additional dealer license plate issued 26 27 to the same dealer. The "regular fee" is the fee set in subdivision (5) of this section for a private passenger motor vehicle of not more than 15 28 29 passengers. 30 Driveaway Companies. - Any person engaged in the business of (8) driving new motor vehicles from the place of manufacture to the place 31 of sale in this State for compensation shall pay a fee of one-half of the 32 amount that would otherwise be payable under this section for each set 33 34 of plates. 35 (9) House Trailers. – In lieu of other registration and license fees levied on house trailers under this section or G.S. 20-88, the registration and 36 license fee on house trailers shall be seven dollars (\$7.00) for the 37 license year or any portion thereof. 38 39 Special Mobile Equipment. – The fee for special mobile equipment for (10)the license year or any part of the license year is two times the fee in 40 subdivision (5) for a private passenger motor vehicle of not more than 41 42 15 passengers.

1	(11) Any vehicle fee determined under this section according to the weight
2	of the vehicle shall be increased by the sum of three dollars (\$3.00) to
3	arrive at the total fee.
4	(12) Low-Speed Vehicles. – The fee for a low-speed vehicle is the same as
5	the fee for private passengers vehicles of not more than 15
5	passengers."
