2	AN ACT TO CLARIFY THE DEFINITION OF SOCIAL WORKER UNDER THE
3	SOCIAL WORKER CERTIFICATION AND LICENSURE ACT.
4	The General Assembly of North Carolina enacts:
5	SECTION 1. G.S. 90B-3(8) reads as rewritten:
6	"(8) Social Worker. – A person engaging in the practice of social work who
7	is not certified or licensed under this Chapter as a Certified Social
8	Worker, Certified Master Social Worker, Licensed Clinical Social
9	Worker, or Certified Social Work Manager.with a bachelors degree or
10	masters degree in social work who has graduated from a school of
11	social work accredited or a school of social work that is a candidate for
12	accreditation by the social work profession's accrediting body or a
13	person who has attained a doctorate in social work or received
14	licensure or certification from the Board."
15	SECTION 2. G.S. 90B-4 is amended by adding a new subsection to read:
16	"(a1) Except as otherwise provided in this Chapter, it is unlawful for any person
17	who is not a social worker as defined in this Chapter to hold himself or herself out to the
18	public by any title or description denoting that he or she is a social worker as defined in
19	this Chapter."
20	SECTION 3. G.S. 90B-10 is amended by adding a new subsection to read:
21	"(a1) Persons who were engaged in the practice of social work and not certified or
22	licensed under this Chapter as a Certified Social Worker, Certified Master Social
23	Worker, Licensed Clinical Social Worker, or Certified Social Work Manager before
24	October 1, 2007, shall be exempt from the academic qualifications required by this
25	Chapter for social workers provided those persons remain continuously employed in the
26	field of social work in North Carolina."
27	SECTION 3.1. G.S. 90B-10 is amended by adding a new subsection to read:

(Public)

General Assembly of North Carolina

1	"(a2) A person engaged in the practice of social work while employed by a county
2	of this State may hold himself or herself out to the public as a social worker only if the
3	title or description includes "county agency social worker" if that person is not a social
4	worker as defined in this Chapter."
5	SECTION 4. The Office of State Personnel shall develop and implement a
6	position classification for persons affected by Section 3 of this act on or before October
7	1, 2007.
8	SECTION 5. Sections 1, 2, and 3 of this act become effective October 1,
9	2007. The remainder of this act is effective when it becomes law.
