1 A BILL TO BE ENTITLED AN ACT TO DEFINE PHYSICAL THERAPY AS A PROFESSIONAL SERVICE 2 3 UNDER THE PROFESSIONAL CORPORATION ACT, TO AUTHORIZE THE 4 NORTH CAROLINA BOARD OF PHYSICAL THERAPY EXAMINERS TO 5 DISCIPLINE PERSONS FOR PAYING FOR REFERRALS OF PHYSICAL THERAPY PATIENTS, AND TO PREVENT CORPORATE OR BUSINESS 6 INTERESTS FROM INTERFERING WITH PROFESSIONAL PHYSICAL 7 8 THERAPY JUDGMENTS CONCERNING THE BEST INTERESTS OF PATIENTS. 9

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 55B-2(6) reads as rewritten:

The term "professional service" means any type of personal or 12 "(6) professional service of the public which requires as a condition 13 precedent to the rendering of such service the obtaining of a license 14 15 from a licensing board as herein defined, and pursuant to the following provisions of the General Statutes: Chapter 83A, "Architects"; Chapter 16 84, "Attorneys-at-Law"; Chapter 93, "Public Accountants"; and the 17 following Articles in Chapter 90: Article 1, "Practice of Medicine," 18 Article 2, "Dentistry," Article 6, "Optometry," Article 7, "Osteopathy," 19 Article 8, "Chiropractic," Article 9A, "Nursing Practice Act," with 20 regard to registered nurses, Article 11, "Veterinarians," Article 12A, 21 "Podiatrists," Article 18A, "Practicing Psychologists," Article 18B, 22 "Physical Therapy," Article 18C, "Marriage and Family Therapy 23 Licensure," Article 18D, "Occupational Therapy," Article 22, 24 "Licensure Act for Speech and Language Pathologists 25 Audiologists," and Article 24, "Licensed Professional Counselors"; 26 Chapter 89C, "Engineering and Land Surveying"; Chapter 89A, 27 "Landscape Architects"; Chapter 90B, "Social Worker Certification 28 and Licensure Act" with regard to Licensed Clinical Social Workers as 29

1	defined by G.S. 90B-3; Chapter 89E, "Geologists"; Chapter 89B,
2	"Foresters"; and Chapter 89F, "North Carolina Soil Scientist Licensing
3	Act"."
4	SECTION 2. G.S. 90-270.26 is amended to add a new subdivision to read:
5	"(7a) Regulate physical therapy professional corporations pursuant to
6	Chapter 55B of the General Statutes and this Article, including
7	adopting rules for the registration of physical therapy professional
8	corporations."
9	SECTION 3. Article 18B of Chapter 90 of the General Statutes is amended
10	by adding a new section to read:
11	"§ 90-270.31A. Physical therapy professional corporations.
12	The Board shall not issue a certification to a professional corporation pursuant to
13	G.S. 55B-6 for the transfer of stock to an individual who is not licensed under this
14	Article unless the individual presents evidence satisfactory to the Board that the laws
15	governing or regulating physical therapy practices and professional corporations in the
16	jurisdiction where the individual is duly licensed and performs physical therapy
17	professional services are equivalent to, or require a higher standard than, the provisions
18	of this Article and Chapter 55B of the General Statutes."
19	SECTION 4. G.S. 90-270.35 is amended by adding a new subdivision to
20	read:
21	"(4a) Practice physical therapy and make physical therapy patient treatment
22 23	decisions based on corporate or business standards or parameters
23	rather than on the best interest of the patient in the physical therapist's
24	sound professional judgment;".
25	SECTION 5. G.S. 90-270.36 is amended by adding a new subdivision to
26	read:
27	"(6a) Violation of G.S. 90-401 by financially compensating or rewarding
28	another person, firm, or corporation for recommending, arranging, or
29	securing employment by a patient."
30	SECTION 6. This act becomes effective January 1, 2006, and applies to acts
31	occurring or offenses committed on or after that date.
