1 A JOINT RESOLUTION HONORING THE LIFE AND MEMORY OF DR.
2 BARBARA KINARD PHILLIPS, DISTINGUISHED NORTH CAROLINIAN.

3 Whereas, Barbara Kinard was born in Winston-Salem on September 5, 1936,
4 to Clarence Kinard and Alma Mae Lowe Kinard; and

5 Whereas, Barbara Kinard attended the Winston-Salem public schools and
6 graduated valedictorian of Atkins High School in 1953; and

7 Whereas, Barbara Kinard received a bachelor of science degree from
8 Winston-Salem State University, a masters degree from Indiana University, and a
9 doctorate degree from the University of North Carolina at Greensboro, and furthered her
10 education by taking courses at Brigham Young University in Utah and the University of
11 California at Berkeley; and

12 Whereas, Barbara Kinard married Garret Elroy Phillips, Jr., and together they
13 had a daughter, Eleanor; and

14 Whereas, Barbara Kinard Phillips mentored countless students throughout the
15 Winston-Salem area as a teacher, guidance counselor, librarian, principal, and an
16 assistant superintendent; and

17 Whereas, Barbara Kinard Phillips served her profession as a member of the
18 American Association of School Administrators and the Association for Supervision
19 and Curriculum Development and as an educator on loan to the Hanes Corporation; and

20 Whereas, Barbara Kinard Phillips was actively involved in almost every
21 aspect of her community, serving on many boards and participating in various civic
22 organizations, including the Winston-Salem Foundation, National Urban League,
23 Winston-Salem Girl Scouts of America, March of Dimes, National Council of Negro
24 Women, The Links, and the Black Leadership Roundtable; and

25 Whereas, Barbara Kinard Phillips served as a trustee of Winston-Salem State
26 University and as president of the Child Guidance Center of Winston-Salem; and

27 Whereas, Barbara Kinard Phillips was a devoted member of Alpha Kappa
28 Alpha Sorority, Incorporated, serving as the organization's 20th national president and
29 the seventh mid-Atlantic regional director; and

1 Whereas, Barbara Kinard Phillips was a faithful member of the First Baptist
2 Church of Winston-Salem for more than 50 years and served as a trustee and chair of
3 the church's personnel and finance committees; and

4 Whereas, Barbara Kinard Phillips received numerous awards and honors, and
5 was recognized by Ebony Magazine as one of the nation's 100 Most Influential
6 African-Americans; and

7 Whereas, Barbara Kinard Phillips died on July 5, 2005; and

8 Whereas, Barbara Kinard Phillips is survived by her husband, Garret Elroy
9 Phillips, Jr., a daughter, Eleanor Phillips Phipps, one grandson, and two sisters; Now,
10 therefore,

11 Be it resolved by the House of Representatives, the Senate concurring:

12 **SECTION 1.** The General Assembly honors the memory of Barbara Kinard
13 Phillips and recognizes her many years of public service to her community and the
14 people of this State.

15 **SECTION 2.** The General Assembly extends its deepest sympathy to the
16 family of Barbara Kinard Phillips for the loss of a beloved family member.

17 **SECTION 3.** The Secretary of State shall transmit a certified copy of this
18 resolution to the family of Barbara Kinard Phillips.

19 **SECTION 4.** This resolution is effective upon ratification.
