SECTION 3. There is appropriated from the General Fund to the Department of Administration, Office of State Personnel, the sum of fifty thousand dollars (\$50,000) for the 2006-2007 fiscal year to provide technical assistance and training to State and local government agencies in carrying out and monitoring compliance with the provisions of this act.
