A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO ESTABLISH AN ADDITIONAL

ASSISTANT DISTRICT ATTORNEY POSITION AND AN ADDITIONAL

VICTIM WITNESS ASSISTANT FOR PROSECUTORIAL DISTRICT 3B.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of eighty-four thousand six hundred ninety dollars (\$84,690) for the 2006-2007 fiscal year to establish the additional assistant district attorney position authorized by this act.

SECTION 3. There is appropriated from the General Fund to the Judicial Department the sum of forty-eight thousand three hundred fifty-four dollars (\$48,354) for the 2006-2007 fiscal year to establish an additional victim witness assistant position for Prosecutorial District 3B.
