  - (e) Report. The Soil and Water Conservation Commission shall report no later than 31 January of each year to the Environmental Review Commission and the Fiscal Research Division. The report shall include a summary of projects that received State funding pursuant to the Program, the results of the evaluation conducted pursuant to subdivision (5) of subsection (b) of this section, findings regarding the effectiveness of each project to accomplish its primary purpose, and any recommendations to assure that State funding is used in the most cost-effective manner and accomplishes the greatest improvement in water quality."

**SECTION 2.** The Community Conservation Assistance Program Advisory Committee shall review the Program prior to expenditure of any funds from the Program. The Advisory Committee shall report on the findings of its Program review to the Speaker of the House of Representatives, the President Pro Tempore of the Senate, the Chairs of the Appropriations Committees of the Senate and the House of Representatives, the Director of the Fiscal Research Division of the Legislative Services Office, and the Environmental Review Commission no later than 31 March 2007.

**SECTION 3.** The first report required pursuant to G.S. 143-215.74M(e), as enacted by Section 1 of this act, is due on or before 31 January 2008.

**SECTION 4.** This act is effective when it becomes law.
