A BILL TO BE ENTITLED

1 AN ACT TO DIRECT THE NORTH CAROLINA WILDLIFE RESOURCES  
2 COMMISSION TO STUDY THE ISSUE OF ALLOWING HUNTING ON  
3 SUNDAY AT A LIMITED NUMBER OF STATE GAME LANDS IN NORTH  
4 CAROLINA.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** The Wildlife Resources Commission shall study the issue of  
8 allowing hunting on Sundays at a limited number of State game lands. In conducting its  
9 study, the Commission shall consider, but is not limited to, the following issues:

- 10 (1) Individual game land suitability for Sunday hunting, including the  
11 status of resident wildlife species, proximity to population centers, and  
12 range of recreational opportunities available.  
13 (2) Allowable hunting activities, including methods of taking and the use  
14 of dogs.  
15 (3) Limiting hunting privileges to times before 9:30 A.M. and after 1:00  
16 P.M. on Sunday.  
17 (4) The needs of persons pursuing nonhunting outdoor recreational  
18 activities, including private landowners, family picnics, hiking,  
19 canoeing, birding, horseback riding, climbing, and biking.

20 **SECTION 2.(a)** In conducting the study, the Commission shall obtain input  
21 from representatives of interested parties, including landowners, the North Carolina  
22 Wildlife Federation, the Sierra Club and other conservation organizations, the North  
23 Carolina Farm Bureau and other agricultural organizations, the North Carolina Horse  
24 Council, hunting clubs and organizations, controlled hunting preserve operators, and  
25 other outdoor recreational clubs and organizations.

1           **SECTION 2.(b)** As a part of the study, the Commission shall conduct at  
2 least one public hearing in each of its nine regions on the issue of allowing Sunday  
3 hunting on selected game lands.

4           **SECTION 3.** The Wildlife Resources Commission shall report its findings  
5 and recommendations, including a recommendation whether to amend, repeal, or leave  
6 intact the existing ban on Sunday hunting, to the Joint Legislative Commission on  
7 Governmental Operations no later than March 15, 2006.

8           **SECTION 4.** This act is effective when it becomes law.
