1 AN ACT TO ESTABLISH THE ONE NORTH CAROLINA SMALL BUSINESS
2 FUND AND TO APPROPRIATE FUNDS TO THE ONE NORTH CAROLINA
3 FUND.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 143B-437.71(b) reads as rewritten:

7 "(b) Purposes. – Moneys in the One North Carolina Fund may be allocated only to
8 the One North Carolina Small Business Fund created pursuant to G.S. 143B-437.80 and
9 to local governments for use in connection with securing commitments for the
10 recruitment, expansion, or retention of new and existing businesses. Moneys in the One
11 North Carolina Fund allocated to local governments shall be used for the following
12 purposes only:

- 13 (1) Installation or purchase of equipment.
- 14 (2) Structural repairs, improvements, or renovations to existing buildings
15 to be used for expansion.
- 16 (3) Construction of or improvements to new or existing water, sewer, gas,
17 or electric utility distribution lines or equipment for existing buildings.
- 18 (4) Construction of or improvements to new or existing water, sewer, gas,
19 or electric utility distribution lines or equipment for new or proposed
20 buildings to be used for manufacturing and industrial operations.
- 21 (5) Any other purposes specifically provided by an act of the General
22 Assembly."

23 **SECTION 2.** Article 10 of Chapter 143B of the General Statutes is amended
24 by adding a new Part to read:

25 "Part 2I. One North Carolina Small Business Fund.

26 "§ 143B-437.80. One North Carolina Small Business Fund established.

1 The One North Carolina Small Business Fund is established as a special revenue
2 fund in the Department of Commerce to be administered by the North Carolina Board of
3 Science and Technology. Moneys in the One North Carolina Small Business Fund may
4 be used for the North Carolina SBIR/STTR Incentive Program and the North Carolina
5 SBIR/STTR Matching Funds Program, as specified in this Part, only.

6 **"§ 143B-437.81. North Carolina SBIR/STTR Incentive Program.**

7 (a) Program. – There is established the North Carolina SBIR/STTR Incentive
8 Program to be administered by the North Carolina Board of Science and Technology. In
9 order to foster job creation and economic development in the State, the Board may
10 provide grants to eligible businesses to offset costs associated with applying to the
11 United States Small Business Administration for Small Business Innovative Research
12 (SBIR) grants or Small Business Technology Transfer Research (STTR) grants.

13 (b) Eligibility. – In order to be eligible for a grant under this section, a business
14 must satisfy all of the following conditions:

15 (1) The business must be a for-profit, North Carolina-based business. For
16 the purposes of this section, a North Carolina-based business is one
17 that has its principal place of business in this State.

18 (2) The business must have submitted a qualified SBIR/STTR Phase I
19 proposal to a participating federal agency in response to a specific
20 federal solicitation.

21 (3) The business must satisfy all federal SBIR/STTR requirements.

22 (4) The business may not receive concurrent funding support from other
23 sources that duplicates the purpose of this section.

24 (5) The business must certify that at least fifty-one percent (51%) of the
25 research described in the federal SBIR/STTR Phase I proposal will be
26 conducted in this State and that the business will remain a North
27 Carolina-based business for the duration of the SBIR/STTR Phase I
28 project.

29 (6) The business must demonstrate its ability to conduct research in its
30 SBIR/STTR Phase I proposal.

31 (c) Grant. – The North Carolina Board of Science and Technology may award
32 grants to reimburse an eligible business for up to fifty percent (50%) of the costs of
33 preparing and submitting a SBIR/STTR Phase I proposal, up to a maximum of three
34 thousand dollars (\$3,000). A business may receive only one grant under this section per
35 year. A business may receive only one grant under this section with respect to each
36 federal proposal submission. Costs that may be reimbursed include costs incurred
37 directly related to preparation and submission of the grant such as word processing
38 services, proposal consulting fees, project-related supplies, literature searches, rental of
39 space or equipment related to the proposal preparation, and salaries of individuals
40 involved with the preparation of the proposals. Costs that may not be reimbursed
41 include travel expenses, large equipment purchases, facility or leasehold improvements,
42 and legal fees.

1 (d) Application. – A business shall apply, under oath, to the North Carolina
2 Board of Science and Technology for a grant under this section on a form prescribed by
3 the Board that includes at least all of the following:

4 (1) The name of the business, the form of business organization under
5 which it is operated, and the names and addresses of the principals or
6 management of the business.

7 (2) An acknowledgement of receipt of the Phase I proposal by the relevant
8 federal agency.

9 (3) An itemized statement of the costs that may be reimbursed.

10 (4) Any other information necessary for the Board to evaluate the
11 application.

12 **"§ 143B-437.82. North Carolina SBIR/STTR Matching Funds Program.**

13 (a) Program. – There is established the North Carolina SBIR/STTR Matching
14 Funds Program to be administered by the North Carolina Board of Science and
15 Technology. In order to foster job creation and economic development in the State, the
16 Board may provide grants to eligible businesses to match funds received by a business
17 as a SBIR or STTR Phase I award and to encourage businesses to apply for Phase II
18 awards.

19 (b) Eligibility. – In order to be eligible for a grant under this section, a business
20 must satisfy all of the following conditions:

21 (1) The business must be a for-profit, North Carolina-based business. For
22 the purposes of this section, a North Carolina-based business is one
23 that has its principal place of business in this State.

24 (2) The business must have received a SBIR/STTR Phase I award from a
25 participating federal agency in response to a specific federal
26 solicitation. To receive the full match, the business must also have
27 submitted a final Phase I report, demonstrated that the sponsoring
28 agency has interest in the Phase II proposal, and submitted a Phase II
29 proposal to the agency.

30 (3) The business must satisfy all federal SBIR/STTR requirements.

31 (4) The business may not receive concurrent funding support from other
32 sources that duplicates the purpose of this section.

33 (5) The business must certify that at least fifty-one percent (51%) of the
34 research described in the federal SBIR/STTR Phase II proposal will be
35 conducted in this State and that the business will remain a North
36 Carolina-based business for the duration of the SBIR/STTR Phase II
37 project.

38 (6) The business must demonstrate its ability to conduct research in its
39 SBIR/STTR Phase II proposal.

40 (c) Grant. – The North Carolina Board of Science and Technology may award
41 grants to match the funds received by a business through a SBIR/STTR Phase I
42 proposal, up to a maximum of one hundred thousand dollars (\$100,000). Seventy-five
43 percent (75%) of the total grant shall be remitted to the business upon receipt of the
44 SBIR/STTR Phase I award and application for funds under this section. Twenty-five

1 percent (25%) of the total grant shall be remitted to the business upon submission by the
2 business of the Phase II application to the funding agency and acceptance of the Phase I
3 report by the funding agency. A business may receive only one grant under this section
4 per year. A business may receive only one grant under this section with respect to each
5 federal proposal submission. Over its lifetime, a business may receive a maximum of
6 five awards under this section.

7 (d) Application. – A business shall apply, under oath, to the North Carolina
8 Board of Science and Technology for a grant under this section on a form prescribed by
9 the Board that includes at least all of the following:

10 (1) The name of the business, the form of business organization under
11 which it is operated, and the names and addresses of the principals or
12 management of the business.

13 (2) An acknowledgement of receipt of the Phase I report and Phase II
14 proposal by the relevant federal agency.

15 (3) Any other information necessary for the Board to evaluate the
16 application.

17 **"§ 143B-437.83. Program guidelines.**

18 The Department of Commerce shall develop guidelines related to the administration
19 of the One North Carolina Small Business Fund. At least 20 days before the effective
20 date of any guidelines or nontechnical amendments to guidelines, the Department of
21 Commerce must publish the proposed guidelines on the Department's Web site and
22 provide notice to persons who have requested notice of proposed guidelines. In addition,
23 the Department must accept oral and written comments on the proposed guidelines
24 during the 15 business days beginning on the first day that the Department has
25 completed these notifications. For the purpose of this section, a technical amendment is
26 either of the following:

27 (1) An amendment that corrects a spelling or grammatical error.

28 (2) An amendment that makes a clarification based on public comment
29 and could have been anticipated by the public notice that immediately
30 preceded the public comment.

31 **"§ 143B-437.84. Reports.**

32 The Department of Commerce shall publish a report on the use of funds in the One
33 North Carolina Small Business Fund at the end of each fiscal quarter. The report shall
34 contain information on the disbursement and use of funds allocated under the One North
35 Carolina Small Business Fund. The report is due no later than one month after the end
36 of the fiscal quarter and must be submitted to the following:

37 (1) The Joint Legislative Commission on Governmental Operations.

38 (2) The chairs of the House of Representatives and Senate Finance
39 Committees.

40 (3) The chairs of the House of Representatives and Senate Appropriations
41 Committees.

42 (4) The Fiscal Research Division of the General Assembly."

43 **SECTION 3.** There is appropriated from the General Fund to the One North
44 Carolina Fund, created pursuant to G.S. 143B-437.71, the sum of five million dollars

1 (\$5,000,000) for the 2005-2006 fiscal year. Of the funds appropriated by this section,
2 the Department of Commerce may use up to three hundred thousand dollars (\$300,000)
3 to cover its expenses in administering the One North Carolina Fund and other economic
4 development incentive grant programs during the 2005-2006 fiscal year.

5 **SECTION 4.** This act becomes effective July 1, 2005.
