2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
3 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE
4 AND TO MAKE A CORRECTION IN A TERM.

5 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
6 appointments to public offices upon the recommendation of the President Pro Tempore
7 of the Senate; and

8 Whereas, the President Pro Tempore of the Senate has made
9 recommendations; Now, therefore,

10 The General Assembly of North Carolina enacts:

11 **SECTION 1.** Ken Morehead of Durham County is appointed to the
12 Acupuncture Licensing Board for a term expiring on June 30, 2009.

13 **SECTION 2.(a)** James R. Britt of Duplin County is appointed to the North
14 Carolina Agricultural Finance Authority for a term expiring on July 1, 2008, to fill the
15 unexpired term of Deborah Johnson.

16 **SECTION 2.(b)** Frank Timberlake of Wake County is appointed to the
17 North Carolina Agricultural Finance Authority for a term expiring on July 1, 2009.

18 **SECTION 3.** Gladys Brooks of Buncombe County is appointed to the Board
19 of Directors of the North Carolina Arboretum for a term expiring on June 30, 2010.

20 **SECTION 4.** Effective July 1, 2005, Michelle E. Piette of Wake County and
21 Robert J. Casmus of Rowan County are appointed to the North Carolina Board of
22 Athletic Trainer Examiners for terms expiring on June 30, 2008.

9 **SECTION 38.** Section 2.3 of S.L. 2005-421 reads as rewritten:

10 **"SECTION 2.3.** Dr. Paul Rush of Scotland County is appointed to the North
11 Carolina Board of Athletic Trainer Examiners for a term expiring on June 30,

13 **SECTION 39.** Unless otherwise specified, all appointments made by this act
14 are for terms to begin upon ratification of this act.

15 **SECTION 40.** This act is effective when it becomes law.
